ORDINANCE NO. I OF 2011

AN

ORDINANCE

*to amend the National University of Modern Languages Ordinance, 2000*

WHEREAS, it is expedient to amend the National University of Modern Languages Ordinance, 2000 (XVIII of 2000), for the purposes hereinafter appearing;

AND WHEREAS the Senate and the National Assembly are not in session and the President is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 89 of the Constitution of the Islamic Republic of Pakistan, the President is pleased to make and promulgate the following Ordinance:—

1. **Short title and commencement.**— (1) This Ordinance may be called the National University of Modern Languages (Amendment) Ordinance, 2011.

(2) It shall come into force at once.

2. **Amendment of section 2, Ordinance XVIII of 2000.**— In the National University of Modern Languages Ordinance, 2000 (XVIII of 2000), hereinafter referred to as the said Ordinance, in section 2, after clause (b), the following new clause shall be inserted, namely:—

“(ba) “Chairman, Board of Governors” means the Chief of Army Staff or his nominee;”.

3. **Amendment of section 3, Ordinance XVIII of 2000.**— In the said Ordinance, in section 3, in sub-section (1), in clause (a), after the word and comma “Pro-Chancellor,” the words and comma “the Chairman, Board of Governors,” shall be inserted.

4. **Amendment of section 10, Ordinance XVIII of 2000.**— In the said Ordinance, in section 10, for sub-section (1) the following shall be substituted, namely:—

“(1) The Chairman, Board of Governor shall appoint a senior serving or retired Army officer, with sufficient experience to ensure the discipline of educational environment visualized for the university, to be the Rector.”.

5. **Substitution of section 11, Ordinance XVIII of 2000.**— In the said Ordinance, for section 11, the following shall be substituted, namely:—

“11. *The Director-General.*— A suitable serving or retired Brigadier shall be appointed by the Chairman to be the Director-General.”.

6. **Amendment of section 13, Ordinance XVIII of 2000.**— In the said Ordinance, in section 13, in sub-section (1) for clause (a) the following shall be substituted, namely:—

“(a) the Chief of Army Staff or his nominee who shall be the Chairman of the Board;

(ab) Inspector General Training and Evaluation Pakistan Army or his nominee;”

7. **Amendment of section 15 , Ordinance XVIII of 2000.**— In the said Ordinance, in section 15, in sub-section (1) for clause (c) the following shall be substituted, namely:—

“(c) Director-General Human Resource Development Pakistan Army;”

## **STATEMENT OF OBJECTS AND REASONS.**
