**F-9(9)/2004-Legis.**—The following Act of Majlis-e-Shoora (Parliament) received the assent of the President on 5th October, 2004, is hereby published for general information:—

ACT No. VI of 2004

further to amend the Code of Criminal Procedure, 1898

Whereas it is expedient further to amend the Code of Criminal Procedure, 1898 (Act V of 1898), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- 1. **Short title, and Commencement.**—(1) This Act may be called the Code of Criminal Procedure (Amendment) Act, 2004.
  - (2) It shall come into force at once.
- 2. Amendment of section 345, Act V of 1898.—In the Code of Criminal Procedure, 1898 (V of 1898), hereinafter referred to the said Code, in section 345, in sub-section (2), in the table, before the entries relating to offence of "Qatl-i-amd", the following new entries shall be inserted, namely:—
