#### Bill

further to amend the National Judicial (Policy Making) Committee . Ordinance, 2002

WHEREAS it is expedient further to amend the National Judicial (Policy Making) Committee Ordinance, 2002 (LXXI of 2002), for the purposes hereinafter appearing;

It is hereby enacted as follows :-

- Short title and commencement. (1) This Act may be called the National Judicial (Policy Making) Committee (Amendment) Act, 2013.
  - (2) It shall come into force at once.
- 2. Amendment of section 3, Ordinance LXXI of 2002.- In the National Judicial (Policy Making) Committee Ordinance, 2002 (LXXI of 2002), in section 3, the words "four Provincial" shall be omitted.

## STATEMENT OF OBJECTS AND REASONS

The Law and Justice Commission of Pakistan, in its meeting dated 4<sup>th</sup> June, 2011, considered the proposal to amend section 3 of the National Judicial (Policy Making) Committee Ordinance, 2002 and observed that after establishment of Islamabad High Court, it is imperative that section 3 of the Ordinance be amended to include the Chief Justice of the Islamabad High Court as member of the National Judicial (Policy Making) Committee (NJPMC).
