Islamabad, the 12th March, 2015

Pakistan Housing Authority Foundation (PHAF) has extended the date for the renewal of membership for Federal Government Employees till 16th March, 2015, on the direction of National Assembly Standing Committee on Housing & Works (H&W). This was told by Managing Director, PHAF, in a meeting held on today on 12th March, 2015, Parliament House, Islamabad, under the chairmanship of **HAJI MUHAMMAD AKRAM ANSARI**, Chairman Standing Committee on H&W. Mr. Muhammad Akram Khan Durrani, Federal Minister for (H&W) was also present in the meeting.

2. Describing the salient features of membership drive, MD PHAF told that only those Federal Government Employees, who are already registered with PHAF, are eligible to apply for renewal. Those employee who have already been allotted apartment, unit / house from PHAF, will not be eligible for renewal of membership. He assured the Committee that PHAF is in the process of providing all the best facilities which will be available to the allottees in Head Office & Regional Offices as well. Those facilities are one window transactions, Verisys system, for transparent transaction of property, directly linked with NADRA, SMS for any information to the allottees regarding his property/transaction, an integrated information system, an upgrading and updating of website, issuance of life time computerized allotment/membership card.

About status /progress of allotment of Sectors F-14/15, Islamabad, the Committee was apprised that a Summary was moved on 6th January, 2015 to the Prime Minister for allocation of these Sectors, for allotment of Plots to Federal Government Employees. The Cabinet Division/CDA has agreed with the proposal of Housing Foundation on division of Commercial Plots on parity basis. The approval of PM Office is still awaited. The Criteria for allotment of plots in the said Scheme is expected to be age-wise seniority. About Bhara-Kahu Scheme, it was told that the Scheme would be re-launched after the decision of the case, presently pending in the Hon. Islamabad High Court for final decision.
