The PAOs should ensure holding of fresh Departmental Accounts Committee (DAC) meeting well before PAC meeting and DAC must be chaired by the PAOs himself/herself. **Only Five (5) hard copies of Ministry's reply/latest DAC Minutes** may be provided for advance study of Chairman/Members, Public Accounts Committee.

5. Auditor General's Office may provide 50-copies of Audit Briefs for advance study of Chairman/Members, Public Accounts Committee at least 7 days before the meeting, a soft copy of Audit Briefs may also be emailed at [nazirpac.na@gmail.com](mailto:nazirpac.na@gmail.com)
