Amendment in Rule 118 of the Rules of Procedure.- that in the Rules of Procedure and Conduct of Business in the National Assembly, 2007, in rule 118, the following new sub-rule (6) may be added namely:

“(6) Copies of the Private Members Bills and Government Bills may be made available to the members at the start of the session. This may not apply to a Bill which in the opinion of the Government is of an urgent nature.”
