

3. Ministries/Divisions/Departments/Audit/AGPR and participants attending the meeting are requested to note the following directives already issued vide this Secretariat's letter No. F.1 (1)/2013-PAC, dated 12th April, 2014 for compliance:-

However, in case of Briefings/Presentations/inquiry reports, 70 coloured copies of the presentations may be forwarded to this Secretariat and 5 copies thereof to Auditor General's Office.
