Islamabad, 21st October, 2020; 39th meeting of the <u>Standing Committee on Law</u> and <u>Justice</u> was held today under the <u>Chairmanship of Mr. Riaz Fatyana, MNA</u> in Committee Room No.7, (04th Floor), Parliament House, Islamabad.

- 2) The meeting started with recitation from the Holy Quran, then, the Committee decided to proceed with the agenda.
- 3) The National Accountability (Second Amendment) Bill, 2019 (Ordinance No XXVII of 2019) (Government Bill). The Committee deferred the same at request of Ministry till its next meeting.
- 4) The Whistleblower Protection and Vigilance Commission, Ordinance No. XXIII of 2019 (Government Bill); after detail deliberations the Ministry withdrawn the same.
- 5) The International Court of Justice (Review and Re-consideration) Ordinance No. VI of 2020 (Government Bill); after detail deliberation the Committee recommends with majority that the Bill may be passed by the Assembly.
- 6) The Constitution (Amendment) Bill, 2019 (Article 179) moved by Mr. Amjad Ali Khan, MNA; after detail deliberations the Committee defer the Bill till its next meeting with observation that the opinion of all four provinces be obtained to proceed further in the matter.
- 7) The Constitution (Amendment) Bill, 2019 (Article 89) moved by Mr. Abdul Qadir Patel, MNA; the Committee deferred the Bill at request and non-availability of Mover.
- 8) The Constitution (Amendment) Bill, 2019 (Article 140B) (Moved by Ms. Kishwer Zehra, MNA); after detailed deliberations the Committee deferred the same till its next meeting.
- 9) The Constitution (Amendment) Bill, 2020 (Amendment in Third Schedule) moved by Mr. Mohsin Nawaz Ranjha, MNA; after detail deliberation the Committee recommends with majority that the Bill may not be passed by the Assembly.
- 10) The Constitution (Amendment) Bill, 2020 (Amendment in Article 251) and "The Constitution (Amendment) Bill, 2020 (Amendment in Article 25A)" moved by Mr. Kesoo Mal Kheeal Das, MNA; the Committee deferred the same till its next meeting due to non-availability of Mover.
- 11) The Constitution (Amendment) Bill, 2019 (Amendment in Article 51) moved by Mr. Junaid Akbar, MNA; after detailed deliberation the Committee deferred the same till its next meeting.

- 12) Legal Practitioners and Bar Councils (Amendment) Bill, 2020 (Amendment in Section 5) moved by Dr. Nafisa Shah, MNA; due to paucity of time the Committee did not considered the same and defer till its next meeting.
- 13) The Constitution (Amendment) Bill, 2020 (Article 140A) moved by Syed Javed Husnain, MNA; after deliberations the Committee deferred the same till its next meeting.
- 14) The Committee decided that the meeting of the Standing Committee on Law and Justice scheduled to be held on <u>22<sup>nd</sup> October</u>, <u>2020</u> be cancelled.
