23rd meeting of the Standing Committee on States and Frontier Regions (SAFRON) will be held on 26th November, 2021 at 10:30 a.m. in Committee Room No. 7 (4th Floor), Parliament House, Islamabad, to discuss the following agenda:-

- 1) Confirmation of minutes of previous meeting held on 4th November, 2021;
 - 2) Comprehensive report/implementation status of the previous recommendations of the Committee;
 - 3) Briefing by the Secretary SAFRON, Islamabad and Chief Commissioner for Afghan Refugees, Islamabad regarding the recruitments made during the last one year in CCAR on regular or daily wages basis etc., also provide eligibility criteria and procedure of recruitments;

 - a) Total number of sanctioned posts, contract posts and daily wages etc. in Gomal Zam Dam;

 - c) Details of local and non-local employees and its share policy;
 - d) Implementation on the agreement of local tribes and WAPDA about the appointment of local staff in Dam;
 - e) Number of employees of Gomal Zam Dam with their responsibilities who were performing duties at Chashma Mianwali;
 - f) Implementation of the directives of the then Chief Executive/President Islamic Republic of Pakistan which are reproduced as under:-

"Preference in employment be given to the local people in the Gomal Zam Dam. Direct employment may not be made by WAPDA and Irrigation department."
 - g) Shifting of R.E. Gomal Zam Dam office from Chashma Mianwali which is situated 170 KM far from Gomal Zam Dam site for active work of the Dam;
 - h) Shifting of Project Director Gomal Zam Dam to dam site;
 - i) Reasons for non-repairing/reconstruction of burnt/damaged unit of power generator plant; and
 - 7) Any other item with permission of the Chair.
