NOTICE

The 5th meeting of the **Special Committee on Balochistan** will be held on **22nd June, 2023 at 01:00 p.m in the Constitution Room (old Committee Room No. 5) (Second floor) Parliament House**. The following will be the agenda of the meeting:-

- 1) *Recitation from the Holy Quran;*
- 2) *Confirmation of minutes of the meeting held on 9th March, 2023;*
- 3) *Re-settlement and rehabilitation of Internally Displaced Persons (IDPs) of Balochistan, who have migrated as consequence of law-and-order situation, before the Population Census 2023. (Ministry of Interior, Ministry of Defence, Chief Secretary Balochistan, Secretary Home and Tribal Affairs Department Balochistan)*
- 4) *Complete data of internally displaced persons from Dera Bugti following the Shahadat of Nawab Akbar Khan Bugti in 2005 is available with provincial authorities. The Provincial Governments in consultation with Federal Government to present a resettlement and compensation plan with a realistic time-line. (Ministry of Interior, All Chief Secretaries of Provinces)*
- 5) *Streamlining Registration and repatriation of Afghan Refugees. Ensure procedure to return all refugees to respective refugee camps with time lines. Remove all lacunas to prevent Afghan Refugees from taking part in any level of elections in Pakistan. (Ministry of Interior, Ministry of SAFRON, Ministry of Foreign Affairs, NADRA)*
- 6) *Implementation of the decisions recorded in minutes of the meeting held in Dera Bugti on 30.09.2001 in respect of appointment of diploma holders and engineers including regularization of third party workers and appointment of legal heirs by the PPL, OGDCL, SSGCL, SNGPL. Decisions and approvals in this regard by the previous federal cabinet in 2020 to be put on record. (Petroleum Division, Chief Secretary Balochistan, MD OGDCL, MD Sui Northern and Sui Southern, MD PPL)*
- 7) *To ensure supply of gas within 5-kilometer radius of the Sui gas field by PPL and SSGCL. Policy with regard to provision of all services to be provided to the local population to be put on record and performance of all other companies to also be presented in this regard. (Petroleum Division, Chief Secretary Balochistan, MD PPL and MD SSGCL)*
- 8) *To ensure implementation of Oil & Gas Companies' policy of facilitating the locals of Jhal Magsi regarding jobs, gas supply, Corporate Social Responsibility (CSR) etc in view of two recently explored wells in Jhal Magsi. (Petroleum Division, Chief Secretary Balochistan, MD OGDCL)*
- 9) *To ensure peaceful land demarcation and handing over to rightful owners in command area of Kuchhi Canal in accordance with revenue record. (Ministry of Interior, Chief Secretary Balochistan, Secretary Home & Tribal Affairs Department Balochistan and Senior Member, Board of Revenue Balochistan)*
- 10) *The Committee, established under the last Defence Minister, made workable recommendations which, along with the ToRs of the committee, may be included in the mandate of the instant Committee and its recommendations, reproduced hereunder, will be implemented in letter and spirit. (Petroleum Division, Chief Secretary Balochistan, MD OGDCL, MD PPL, MD SSGCL, MD SNGPL and Senior Member, Board of Revenue Balochistan)*
 - I. *The OGDCL was directed to make lease payment for 29227 acres (under control/utilization of OGDCL) from July 2020 to date and vacate the unrequired land for stopping further accumulation of lease charges.*
 - II. *The OGDCL was directed to execute a new agreement or extend previous agreement, within two weeks, for next term w.e.f 01-01-2021 to hire 4300 acres in Uch Gas Field to continue lease/rent payments which were discontinued since December 2020. The OGDCL was also directed to pay arrears of rent from January 2021 to date.*
 - III. *The OGDCL was directed to hire 48 well chowkidars on 16 wells, in Uch Gas Field, as per agreement executed between Nawab Muhammad Akbar Khan Bugti and Ministry of Petroleum & Natural Resource on 30-09-2001. For the purpose of hiring, OGDCL was directed to collect list of landowners, with ownership duly verified by the D.C Dera Bugti, from Nawabzada Shazain Bugti.*
 - IV. *The Ministry of Petroleum and Natural Resources was directed to implement the agreement, executed between Nawab Muhammad Akbar Khan Bugti and Ministry of Petroleum & Natural Resource on 30-09-2001, in letter and spirit, including following.*
 - a) *The PPL and OGDCL were directed to ensure provision of gas in 5 km radius of the Gas fields, as per rule.*
 - b) *The PPL was directed to maintain/repair Sui – Kashmore road on permanent basis as required vide the agreement dated 30-09-2001.*

- c) The PPL and OGDCL were directed to provide lists of officers/officials hired from 2001 to date and also mention officers/officials hired from Dera Bugti.
- d) The OGDCL was directed to hire guards/line-walkers as per agreement dated 30-9-2001.
- V. The SSGPL may collect Court orders, regarding release of salaries of its 10 employees, from Nawabzada Shazain Bugti, and submit reply whether or not the company will implement the Court directives/orders.
- VI. The Ministry may dehire all well chowkidars who are not landowners of well sites. Nawabzada Shazain Bugti may provide list of landowners, with ownership duly verified by the D.C Dera Bugti, in the next meeting.
- VII. It was recommended that for avoiding any bloodshed, the D.C Dera Bugti might get help from the security/paramilitary forces and out of 14000 acres, disputed land between Bugti and Bakhlani tribes, give complete possession of land of Bugtis to them within a month.
- VIII. PPL informed that from 2001 to onwards, 97 Officers and 78 Diploma Holders were hired. PPL may provide complete data of officers and Diploma holders hired since 2001 to date including, the complete list of applicants; domicile/addresses of candidates; list of locals declared ineligible and list of officers hired from outside Dera Bugti Agency; and
- 11) Any other agenda with the permission of the Chair.
