5. Through a planned conspiracy under politically motivated workers of a specific party, the sensitive, Defence Centric installations in the country, were targeted and attacked on the 9th of May, 2023; a detailed presentation from the Inspector General's of Police, Punjab and Khyber Pakhtunkhwa be given, consisting information of all the attacks throughout Pakistan:-

The presentation may also include answers to the following questions;

 - i. During these attacks how many government officials were injured and attacked by the mob and which services were rendered for their betterment by government? And;
 - ii. Which appreciation was bestowed to the victims and forces officials who defended the aforesaid installation of the government as they risked their lives for the Pakistan?
(Inspector General of Police from Punjab and Khyber Pakhtunkhwa, to attend the meeting and brief the committee on the above issue).
6. Report from Cyber Crime Wing of F.I.A, be presented regarding the Social Media-bound propaganda against Pakistani Armed Forces and also suggest that which measures have been taken to stop these condemnable incidents which are planned on the whims and wishes of foreign Pakistanis along with answering following questions in the meeting;
7.
 - i. The propaganda against Pakistan Armed Forces, overseas, is expanding day by day what measures have been taken against these propagandists, in greater interest of Pakistan?
 - ii. How many Social Media activists who were the source of propaganda against Pakistan Armed Forces have been tracked and how many were ignored and why?

8. Detailed Briefing and presentation of complete report from F.I.A on the following issues:-
 - i. Provision of complete list of the human traffickers/ immigrant agents, especially of those involved in foreign illegal trafficking of people through sea. Also provision of the list of fair/legal immigrant agents working under government of Pakistan.
 - ii. What action has been taken against the human trafficking agents involved in the recent incident of the capsizing of Greece bounded ship, therein a huge number of Pakistani immigrants inundated and the death toll raised to almost 300 people.
 - iii. What measures are taken from FIA to prevent gender based victimization of women through misuse of telecommunication tools, via on call black mailing's? How many suicide cases are reported monthly/annually basis, due to this menace? Complete data in this regard with numbers of cases reported, be provided. What steps by government are being taken to prevent this sort of women victimization?
9. Reference to the meeting of the Standing Committee on Interior held on 17.11.2022, for deliberation and implementation on Police Reforms, all the Inspector Generals of Police are requested to attend the meeting.
10. The Sub-Committee constituted on "to look into the matter related to CNICs of Biharis", to present its report in the meeting.
11. Detailed briefing by Inspector General of Police, ICT, regarding the law and order situation and increased magnitude of street crimes in Islamabad.
12. As per general Public opinion, illegal Afghan refugees are a big reason behind the increased street crimes and worsening law and order situation. What policy measures to manage these threats have been taken by Police, throughout the country and what is the policy status of the ministry of Interior regarding these Afghan refugees residing into the every nook and corner of Pakistan?
13. Detailed Briefing by Chairman CDA on rules and regulations of the CDA.
14. Calling Attention Notice by **Ms. Asiya Azeem**: Regarding Sale and Lease of Commercial Buildings for the Residential Purposes without completion Certificate in Islamabad.
15. Calling attention Notice by **Ms. Asiya Azeem**, MNA regarding matter of a Public Importance "issue of encroachment i.e. illegal shops, hand carts at footpaths in the commercial markets of Islamabad, causing grave concern amongst the public".
16. Matter moved in the House on 24th November, 2022 by **Ms. Aliya Kamran**, MNA regarding the issue of leakage of rain water from the roofs and walls of the Parliament Lodges; Status/report be given by CDA on the recommendations of the last meeting held on the 24th of May, 2023. As per, committee's directives, Secretary Finance, Ministry of Finance, Member Engineering, CDA and Member Finance CDA must attend the meeting to resolve perennial issue of Parliament Lodges' lifts and other maintenance related issues raised by the hon. MNA, Ms. Aliya Kamran.
17. Matter referred to the Standing Committee on Interior, moved by **Mr. Qadir Khan Mandokhail**, MNA, on 30th May, 2023 regarding the issuance of PRC, domicile and death Certificate through NADRA office to avoid forgeries.
18. A detailed briefing/report is to be provided by the Secretary Interior through Inspector General Punjab Office on Kacha area operation, South Punjab, and also provide the information Through security agencies as detailed below:
 - i) Who is the actual owner of agricultural land spreading over nearly seventy KM in Kacha area and by whom it is presently occupied as per record of Land Revenue Department;
 - ii) Details of persons who cultivates the said thousands of acres of land in Kacha area at present and the names of those politicians/Government officers who are backing/supporting these illegal occupants of land ; if any;
 - iii) The details and number of schools build in Kacha, details of functional Schools along with detail of Government staff/students thereof;

iv) The number of bridges and *Nullahs* constructed over and along side the roads in *Kacha* area, where no such structure is existing; the reasons thereof;


v) Complete detail of the funds released/issued for construction of schools, hospitals, roads and other development works at Federal/Provincial levels in said *Kacha* area and also details of approved development projects for the said area during the last thirty years;

vi) Number of criminal gangs presently active in *Kacha* area and the names of those who are backing them at present and also the details of those who used to support them in the past;

vii) The names of persons who are involved in the smuggling of wheat from said area and also names of those who are backing/supporting them; and

viii) The details of groups which are quarreling each other over awarding of contract of sand in *Kacha* area along with the names of real beneficiaries at back door.


