52<sup>th</sup> meeting of the Standing Committee on **Interior** will be held on **8<sup>th</sup> August, 2023 at 11:00 a.m in Committee Room of Ministry of Interior R-Block, Islamabad**, to discuss the following agenda items: -

5. Through a planned conspiracy under politically motivated workers of a specific party, the sensitive, Defence Centric installation in the country, were targeted and attacked on the 9<sup>th</sup> of May, 2023; a detailed presentation from the Inspector Generals of Police, Punjab and Khyber Pakhtunkhwa be given, consisting information of all the attacks on the following historic military installations of Pakistan armed forces:-

1. General Headquarters (GHQ), Rawalpindi.
2. Corps Commander House, Lahore (Jinnah House).
3. Forces Monuments of PAF in Mianwali.
4. Askari Tower Lahore.
5. Radio Pakistan Building, Peshawar.

Plus all other sensitive forces installations & civil buildings.

The presentation may also include answers to the following questions:

- i. During these attacks how many Government officials were injured and attacked by the mob and which services were rendered for their betterment by government? And;
- ii. Whether appreciations were bestowed to the victims by the government as they risked their lives for the Pakistan?
- iii. Details of all the Security agencies whose officers are selected for participation and National Awards/rewards.
- iv. List of those Pak Armed Forces & Police & all other security agencies whose troops or divisions armed forces & civil both, were called and they performed their best must be given appreciation letters.

(On above item, Inspector General of Police from Punjab and Khyber Pakhtunkhwa, to attend the meeting and brief the committee in next meeting of the committee, about the progress, update & hurdles in fulfillment of the above issue.


6. Detailed briefing/report is to be provided by the Secretary Interior through Inspector General of Police office on Kacha area operation, South Punjab and also provide the information through security agencies as detailed below:

1. Who is the actual owner of agricultural land spanning over nearly seventy KM in Kacha area and by whom it is presently occupied as per record of Land department;
2. As to who cultivates the said thousands of acres of land in Kacha area at present and the names of those politicians/Government officers who are backing/supporting the illegal occupants;
3. The number of schools in Kacha which are functional along with detail of staff/ students thereof;

4. The number of bridges constructed over nullahs in Kacha area, where no such structure exists; the reasons thereof;
  5. Complete detail of the funds issued for construction of schools, hospitals, roads and other development works at Federal/ Provincial level in Kacha area and also detail of approved development projects for the said area during the last thirty years;
  6. Number of criminal gangs presently active in Kacha area and the names of those who are backing them at present and those who have been supporting them in the past;
  7. The names of those persons who are involved in the smuggling of wheat and also names of those who are supporting them; and
  8. The groups which are quarreling over award of contract of sand in Kacha area along with the names of beneficiaries whereof.
7. Detailed briefing by Executive Director Nishtar Hospital on the issue raised in the meeting of Standing Committee on dated 18<sup>th</sup> July, 2023.

The committee taken up a matter regarding incident of a patient Hassan S/O Atta Ullah who was playing in home and accidentally his hand was injured because of 'Toka Machine' due to which he was admitted in Nishtar Hospital Emergency Multan for re-implantation of hand but instead re-implantation his hand was cut off due to non-supervision of Dr. Naheed Chaudhry Incharge Burn Centre Multan. It was decided by the Committee that a questionnaire will be sent to present Executive Director Burn Centre Nishtar Hospital Multan as under:

- i. Why the hand of Hassan S/O Atta Ullah, was cutoff instead of providing the best surgical treatment for re-implantation.
  - ii. Was the PT remains available in emergency on time for re-implantation?
  - iii. Did doctors of PIBC attended the above patient on time and attempted the re-implantation?
  - iv. Did head of department supervise the surgical procedure or help the juniors in the procedure?
  - v. Who was the Incharge of burn centre/ head of burn centre at the time of incident.
  - vi. Details of any inquiry conducted in the matter?
  - vii. What action has been taken by the Provincial Government against the responsible?
8. Detailed Report of the Sub-Committee constituted under the Chairmanship of Mr. Agha Rafiullah, MNA, along with the content of the Sub Committee report which was adopted therefore, the latest status of implementation of directions of the Committee be apprised. The comprehensive report regarding blocked CNICs of Beharis who lost their documents during the migration from India to Pakistan, reasons for not unblocking the same, they are suffering, their future is at stake due to having no citizenship.
- To inquire the matter send the answer of above questionnaires to find the truth of fact in the matter before the Committee.
9. Report for Cyber Crime Wing of FIA be presented on the Social Media – bound propaganda against Pakistani Armed Forces and also suggest that which measures have been taken to stop these condemnable incidents which are planned on the whims and wishes of foreign Pakistanis along with answering following question in the meeting;
- i. The Propaganda against Pakistan Forces overseas, is expanding day by day with measures have been taken against these propagandist, in greater interest of Pakistan ;
  - ii. How many Social Media activists who were the source of propaganda against Pakistan Armed Forces have been tracked and how many were ignored and why;
  - iii. Implementation status of the recommendations of the past meetings held under the meeting number 47 to 51;
10. Provide the list of all the departments which have been bestowed with the appreciation awards, in the wake of countering the attacks 9<sup>th</sup> of May, 2023, by the Federal government of Pakistan.
