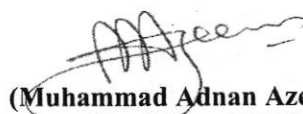

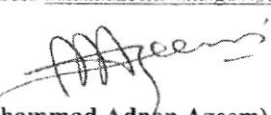

- (4) The PAO must hold and chair afresh DAC meeting before the PAC meeting. Submit five hard copies and one soft copy of the Ministry's replies and DAC minutes to the Secretariat.
- (5) The Auditor General's office must provide 20 copies of the audit briefs at least three days before the meeting.
