6. ***Mr. Iqbal Muhammad Ali Khan:**
(Deferred during 23rd Session)

Will the Minister for Interior be pleased to refer to the Question No.23 replied on 07-02-2020 and state:

- (a) when the forensic audit for period from 1st July, 2011 to 30th June, 2016 will be completed;*
- (b) the total amount of fraud committed alongwith names and designations of the officials involved in fraud;*
- (c) the details of the names of the officials against whom enquiry conducted to hold the responsible, how many times such enquiry has been conducted alongwith its details; and*
- (d) when such enquiry will be completed?*

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) The forensic audit of the Jammu & Kashmir Cooperative Housing Society for the period from 1st July 2011 to 30th June, 2016 has almost been completed whereas final report from the Auditing Firm is awaited.

As per report of audit firm M/s Mushtaq & company Chartered Accountant for completion of Forensic Audit of J&KSCHS the following third parties (experts) reports are mandatory to obtain as defined in TOR's:-

The Auditor has further submitted that as soon as he gets the mandatory reports / information / record from the third parties (experts) as well as from the Society he will submit the Forensic Audit report of Jammu & Kashmir Cooperative Housing Society, Islamabad -without any delay.

(b) As the forensic audit report has not been finalized therefore, the requisite details can not be provided at this stage. Exact Amount will be available after completion of Forensic Audit.

45. ***Mr. James Iqbal:**
(Deferred during 23rd Session)

Will the Minister for Interior be pleased to state the names of countries whose citizens can proceed Pakistan without visa and Passport at present?

Minister for Interior (Mr. Ijaz Ahmad Shah): At present Pakistan has visa abolition agreement with 46 countries whose citizens can visit Pakistan without obtaining Visa, however Passport is a mandatory requirement for international travelling. There are 12 countries with whom Pakistan has Visa abolition agreement only for Diplomatic Passport holders, while the number of countries where the holder of Diplomatic and official Passport holders can visit without obtaining visa is 32. The List of these countries is attached at

Annex-“A”. As per para (09) of Passport & Visa Manual 2006 Official Gratis Passport (Blue) is issued to entitled persons as per detailed at **Annex-“B”**. As per para 45 of Passport & Visa Manual 2006 Diplomatic Passport (Red) is issued to entitled persons as per detail at **Annex-“C”**. Further the holder of Ordinary Passport (Green) can visit 02 countries without obtaining visa.

40. ***Shazia Marri:**
(Deferred during 23rd Session)

Will the Minister for Overseas Pakistanis and Human Resource Development be pleased to state:

- (a) whether the Government has taken the notice of non-compliance of international labour standards in textile industry due to which country textile industry has faced some setbacks in international exports; if so, the details thereof; and*
- (b) what steps are being taken to ensure compliance of international labour standards in textile industry in order to boost the export of textile industry in international market?*

Minister for Overseas Pakistanis and Human Resource Development:

(a) M/o Overseas Pakistanis & Human Resource Development (OPHRD)

- i. The enactment of labour legislation and enforcement is a Provincial subject, under 18th Constitutional Amendment Act. However, as per Entry 32 of the Federal Legislative List (Part-I) the subject of “International Treaties, Conventions and Agreements and International Arbitration” rests with the Federal Government.
- ii. The Observations raised by international organizations regarding non-compliance of international labour standards including textile industry are received in this Ministry which are forwarded to the concerned Ministries/Divisions and Provincial Governments for

taking necessary measures to address those issues. The Federal Government prepares comprehensive report on the basis of information received from concerned stakeholders and submits to international organizations through Pakistan Mission at Geneva.

- iii. This year due to COVID-19 the reports on ratified ILO Conventions initially requested for this year are deferred till 2021. ILO has asked to provide supplementary information in respect of reports on ratified Conventions that were submitted during 2019. Whereas, the reports on ma-ratified Conventions which were to be submitted by 28-02-2020 are now to be submitted by 28-02-2021.
- iv. Since, 2017 the Federal Government is submitting annual labour inspection reports to ILO containing data regarding number of Inspectors, nature of inspections, prosecutions, fines etc. as it is required-under ILO Convention No, 081: Labour Inspection ratified by Pakistan.
- v. The Federal Government through technical assistance of ILO Country Office in Pakistan developed a model law on Occupational Safety & Health (OSH) and it is shared with Provincial Governments. Over the years Governments of Sindh and Punjab have enacted their OSH law whereas, Governments of Khyber Pakhtunkhwa and Balochistan are doing consultations in the matter.
- vi. In 2014, this Ministry constituted Federal Tripartite Consultation Committee which also reviews the progress of provincial labour departments regarding International Labour Standards (ILS). Similar Tripartite Forums have also been established at provincial levels to overlook the labour related issues including compliance of ILS.

The responses received from Provincial Governments are as follows:—

Punjab

The Punjab Province is already fulfilling its responsibilities with regard to implementation of labour laws and details have been highlighted in reply to the Question b.

Khyber Pakhtunkhwa

In the province of Khyber Pakhtunkhwa, textile industries exist in the shape of cotton/ spinning factories. In order to ensure observance of ILS, the Government of Khyber Pakhtunkhwa has enacted a number of labour laws. These labour laws are regularly implemented by the labour department in all the commercial and industrial establishments and that's how the international labour standards are implemented.

Balochistan

There are some textiles mills in the Hub city of Balochistan which are inspected on regular basis, however, recently special inspections have been carried out by the Inspectors in the textile mills of Hub with focus to address non-compliance of International Labour Standards. Most workplaces were found complied and minor non-compliances were noticed in few cases for which the employers were issued notices to proceed with productions in conformity with ILS; else, the legal action under labour laws would be initiated against them.

Sindh

(b) M/o Overseas Pakistanis & Human Resource Development (OPHRD)

The steps taken by Government of Pakistan to ensure compliance of international labour standards in all sectors including textile industry in order to boost the export of textile industry in international market are as follows:—

- i. **Scheme of Preferences (GSP) Plus:** Pakistan was granted GSP Plus Status in 2014 by European Union (EU) for a period of two years subject to satisfactory progress of Pakistan on 27 UN Human Rights Conventions including 08 labour related Conventions. The

textile sector has benefitted the most from the GSP Plus Status. The EU requires progress report on compliance of these Conventions after every two years and on the basis of progress made by Pakistan the GSP Plus Status has been extended. The EU had granted extensions in GSP Plus status to Pakistan in 2016, 2018 and 2020 due to satisfactory performance of Pakistan over the 27 UN Conventions including 08 labour related Conventions. The EU appreciated the efforts made by the Government of Pakistan and hoped that the significant concrete progress would be made on issues highlighted by the EU.

- ii. **National Labour Protection Framework (NLPF):** To improve compliance over ratified ILO Conventions in the year 2017, this Ministry developed a NLFP, in collaboration with ILO CO to guide the Provincial Governments for developing new labour laws aligned with International Labour Standards (ILS) for legislation, implementation, monitoring and reporting with proposed timelines, covering also are Child Labour, Forced Labour, Freedom of Association and Collective Bargaining, Non-Discrimination, Labour Inspection, Social Dialogue, Occupational Safety and Health (OSH). The Provinces have adopted the NLPF and have also integrated it with their provincial policies.
- iii. International Labour Organization (ILO), Country Office (CO) in collaboration with this Ministry completed number of projects to strengthen the labour Inspectorates with special focus on textile sector. Two important projects were “Sustaining GSP Plus facility by strengthening compliance with labour standards” and “Strengthening Labour Inspection System”.
- iv. At present International Labour Organization (ILO), Country Office (CO) in Pakistan is implementing its Decent Work Country Programme-III which focuses on four priority areas including strengthening compliance with international labour standards through social dialogue. The major project under this programme is “International Labour and Environment Standards application in Pakistan’s Small and Medium Enterprises” with particular focus on textile industry.
- v. Over the years the Provincial Governments have strengthened their labour Inspectorates by increasing number of labour

Inspectors and conducting regular inspections of factories to ensure enforcement of labour laws.

The responses received from Provincial Governments are as follows:-

Punjab

To ensure compliance of the international labour standards in the textile industry in Punjab, the following note-worthy measures have so far been taken:

- i. For workplace safety and health in the industry, a new legislation titled as the Punjab Occupational Safety & Health Act was passed by the Provincial Assembly of the Punjab during the year 2019;
- ii. In order to ensure payment of minimum wages as notified by the government, a legislation named as the Punjab Minimum Wages Ordinance, 1969 is being strictly enforced through the subordinate field formations;
- iii. The concept of uprooting the child labour from the textile industries stands established in Punjab. In order to achieve this objective, the previous legislation on child labour has been repealed and a new legislation titled as the Punjab Restriction on Employment of Children Act was passed by the Provincial Assembly of the Punjab in the year 2016;
- iv. Similarly, earnest efforts have also been made in Punjab to combat the menace of bonded labour from the industries. In order to achieve this objective, another legislation named as the Punjab Bonded Labour System (Abolition) (Amendment) Act was passed by the Assembly in 2019 in order to incorporate far-reaching amendments in the existing legislation on bonded labour named as the Punjab Bonded Labour System (Abolition) Act, 1992;
- v. Basic requirements of the “Better Work Programme (BWP)” introduced by the ILO are being fulfilled in letter and spirit in Punjab;
- vi. All out efforts are being made to get implemented the labour laws in the textile sector through a new inspection system focused on computerized and online system hence, minimizing human interaction;
- vii. Training programmes for the Inspectors have been introduced highlighting the significance of the International Labour Standards

(ILS) in collaboration with the ILO. Almost all Inspectors have so far been trained under the said joint venture launched by the Punjab Labour Department and the ILO.

Khyber Pakhtunkhwa

The inspecting staff of the Labour Department is notified under these Provincialized labour laws and inspects all industries including textile industries, to ensure the implementation of Provincialized labour laws and take action if in any industry violation is found.

Balochistan

The employers as well as workers of the textile sector have been briefed about benefits of compliance with International Labour Standards during the course of inspection specially designed for the purpose.

This will remain continue with the proactive and re-active Labour Inspection with proper central monitoring system. Apart from this, the violators of Labour laws and Rules will also be prosecuted in the Labour Courts.

Sindh

1. ***Ms. Romina Khurshid Alam:**

Will the Minister for Interior be pleased to state:

- (a) *whether it is a fact that CDA does not have up to date allotment record of several plots of different sectors, consequently, dubiousness and duplication in allotment of several plots have been made by the authority; if so, the details of such plots, allotted in the names of more than one person;*
- (b) *whether such act on the part of CDA is tantamount to malpractices of good governance;*

- (c) *if so, whether the Government has conducted an independent audit of such dubious and duplicating allotment of plots in order to bring responsible accountable; if so, the details thereof; and*
- (d) *what remedial steps are being taken by the Government in this regard?*

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) Allotment record of CDA is currently available both in the allotment register and computer system. However, change in layout plan at times leads to double allotment re-sizing of plots or at times plots come under deep depression which requires new allotment. In certain cases, double allotment has also been detected through special audit of record in which matter has been referred to FIA for investigation. Details are attached.

(b) At the moment the record of allotment is not only maintained in allotment registers but is also maintained in computer system. However, malpractices detected in certain cases are already under investigation.

(c) Annual audit of record of Directorate of Land and Rehabilitation is carried out by external auditors of Auditor General of Pakistan. 41 Cases of fake allotments were detected as a result of audit exercise and the matter has been referred to FIA for independent investigations.

(d) Cases of all dubious and fictitious allotments are referred to FIA for detailed audit / investigation.

Will the Minister for Interior be pleased to state:

- (a) *the total cost of under construction Parliament Lodges alongwith the work completed so far;*
- (b) *whether the cost of the said project have been increased; if so, the reasons thereof; and*
- (c) *the time by which the remaining work will be completed?*

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) Total cost of the project (Parliament Lodges) is Rs.2728.45 million. So far work of Cost Rs. 1292.898 million has been executed which is 47% of the project cost.

(b) The cost of project has not been increased and the project was remained stalled. The project for balance work will be retendered & rescheduled shortly.

(c) Remaining work will be completed by 30-06-2022 approx subject to availability of funds under PSDP.

3. ***Moulana Abdul Akbar Chitrali:**

Will the Minister for Interior be pleased to state the reasons for non-cleanliness of the Parliament Lodges and servant quarters (inside/outside) due to which condition of the same is extremely bad?

Minister for Interior (Mr. Ijaz Ahmad Shah): It is submitted that the civil dismantle store is being maintained by the CDA in the basement under the servant quarters. During cleaning of civil store some dismantle/ carpets/ broken furniture etc. was stacked outside which was removed that same day and un-serviceable material was disposed of to a suitable location. Now the area is clear in all respects.

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) NADRA Registration Centres are operational in all district Headquarters and most of Tehsils of the Country. Tehsil-wise list of NRCs is attached as **(Annex-A)**.

(b) More than 200x Mobile Registration Vans (MRVs) are being utilized in Tehsils where law and order situation is not favorable and where unregistered population is very less. However, efforts are in hand to expedite establishment of NADRA Registration Offices in left over Tehsils.

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) Park Enclave Scheme Phase-I was announced in July 2011. The intimation/offer letters were issued to successful applicants.

(b) The amount collected in Park Enclave Phase – 1 by CDA till 31-08-2020 is 6594.971 Million and Park Enclave Phase –1 Extension is 2906.221 Million.

(c) The infrastructure Development works in 92% area of Park Enclave Phase-I (*i.e.* Roads, Drawings, Water Supply, Over Head Water Tank, Tube Wells, Sanitary Sewerage, Street Lights. Hard Landscaping of Parks etc.) stands completed since December 2016 and accordingly, possession of 720 Nos. Plots out of total 781 Nos. plots were handed over to their allottees.

Out of remaining 61 Nos. plots possession of further 52 Nos. plots has also been intimated to be handed over to their allottees. Infrastructure development work of remaining 09 Nos. plots will be taken up as soon the built up area issue is resolved by the Director, Lands & Rehabilitations Dte, CDA Infrastructure development works in 98% area is completed.

8. ***Dr. Shazia Sobia Aslam Soomro:**

Will the Minister for Interior be pleased to state:

- (a) *whether it is a fact that the allottees of Sector E-12 and D-13, Islamabad are waiting to get the possession of their plots for the past 31 years;*
- (b) *if so, when will the process of demolition of illegal encroachments in Sector D-13 and E-12 be initiated or started?*

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) The land of Sector D-13 was acquired under D.C, CDA Award dated 22/08/2008. As per land sharing policy 2007, the award of BUP is to be announced and compensation/ rehabilitation benefits are to be given to the affectees against acquired BUP. It is mentioned that the Award of BUP has not been announced and possession has not been taken over by CDA from the affectee of D-13 yet. At site of Sector D-13, the BUPs of affectees still exist. Therefore, the possession of plots could not be handed over to allottees of Sector D-13.

The Compensation against the BUP and Land regarding affectees of E-12 is in process under the supervision of commission constituted by Islamabad High Court, Islamabad. Moreover, the development work of North Service Road is also in process.

After the directions of IHC, commission and competent Authority the compensation will be paid to the affectees and possession will be given to Sector Development Directorate for development work in Sector E-12.

(b) After completion of all prerequisite in accordance with rules & regulations of CDA as per Awards announced, and final decision of the IHC and Commission process of demolition of Illegal encroachers will be started in Sector D-13 and E-12.

9. ***Moulana Abdul Akbar Chitrali:**

Will the Minister for Interior be pleased to state:

- (a) *whether it is a fact that the amount of Rs.12 cror which was announced by the factory owner of Baldya Factory, Karachi to disburse the same each two lacs amongst the every affectees of the said factory for three years on September 11th, 2012;*

- (c) *whether it is also a fact that the amount of Rs.52 cror transferred by a German company to world labour organization which could not be provided to the affectees;*

10. ***Mr. Muhammad Aslam Khan:**

Will the Minister for Interior be pleased to state:

- (a) *whether it is a fact that CDA had allotted plots to residents for vacating Kachi Abadis;*
- (b) *the names and number of those of Kachi Abadis amongst the aforesaid Kachi Abadis which have been vacated;*

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) Yes, it is fact that CDA have allocated/offered plots to eligible dwellers of recognized katchi abadies at Model Urban Shelter Project (MUSP) Farash. The allotment letters have not been issued so far. However it has been proposed to competent Authority that after scrutiny of name /dwellers and status CDA may start issuing allotment to original bonafide dwellers of katchi abides in (MUSP) Farash.

(b) Following five (5) recognized katchi abadies with location are vacated completely or partially.

(c) There are 213 bonafide dwellers of Katchi abadi Essa Naghari in Sector Islamabad, out of which 75 bonafide dwellers have been allocated plots in (MUSP) Farash. Katchi abadi Essa Naghari has been vacated partially. For remaining dwellers, balloting is required for which case is being forwarded to competent authority. The residents were allocated plots / handed over possession of plots subsequent to demolition of houses in Katchi abadi Essa Naghari and other dwellers are still residents in same Katchi abadi.

(d) The name of those dwellers who have been allocated plots, are at **Annex-I.**

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) As per Section 36 or West Pakistan Land Revenue Act, 1967 and its enabling Land Revenue Rules, 1968 the appointment of Numberdar / Headman is still enforced in all the villages of Islamabad.

There are Total 112 Mouzas / villages of Islamabad in all of which Numberdars are working.

(b) Rules 22 of Land Revenue Rules, 1968 describe the duties of Numberdari / Headman, which is reproduced here below:

22. **Duties of Headmen:**—In addition to the duties imposed upon headmen under any other law, a headman shall.

- (i) collect, by due date, the land revenue and all sums recoverable as land revenue, from the estate, or sub-division of an estate in which he holds office, and pay the same personally or by revenue money order or by remittance of currency notes through the post or at place where treasury business is conducted by the State Bank of Pakistan, or any other Bank, by cheque, on a local bank, at the place and time appointed in that behalf, to the Tehsildar concerned;
- (ii) collect the rents and other income of the common land, and account for these to the persons entitled thereto;
- (iii) issue receipts in Form I to the land-owners and others, in token of having recovered the Government dues from them;

Explanation.—The Tehsildar should arrange to supply printed receipt books (Form-I) to the headmen, free of cost, according to their requirements.

12. ***Mr. Abdul Qadir Patel:**

Will the Minister for Interior be pleased to state:

- (a) whether relevant authorities have taken notice of large number of unsolicited calls, which are made by fraudulent people to rob common man in general on different counts;*
- (b) if so, the details thereof and the action taken by the authorities thereto;*
- (c) whether it is a fact that relevant authorities have failed to apprehend owners of such SIMs, which are used in such unsolicited calls;*
- (d) whether is it possible to use such SIMs for such calls after biometric verification; and*
- (e) what steps are being taken by the Government to make be holder or users of such SIMs accountable in true spirit of Prevention of Electronic Crimes Act, 2016 and play proactive role to stop such menace forthwith?*

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) Under section 25D Telegraphic Act of Unsolicited calls on GSM is mandate of Local Police. During current year under section 13, 14, of PECA CCW-HA has received total 7577 complaints regarding these unsolicited/fraudulent calls where common people were financially deceived.

(b) Out of 7577 complaints, 1277 were converted into enquiry and 14 cases were registered in this regard.

(c) CCW-FIA track and trace the owner of such SIMs and interrogates them. The interrogation revealed that all such SIMs were activated fraudulently by using different fraudulent techniques like silicon thumb impression etc.

(d) Yes it is possible that after biometric verification such SIMs can be used for unsolicited calls. Under section 17 PECA “Unauthorized Issuance of SIMs Cards” is mandate of PTA to check and monitor the illegal SIMs

biometric verification. During current year CCW-FIA registered 07 FIR u/s 17 and 7 accused are arrested in recovery of 7 BVS devices and 2045 Silicon Thumb impression and 5400 sheets alongwith voter lists.

(e) CCW-FIA established special team in every Cybercrime Reporting Center which deals with complaint against such unsolicited caller who defraud the common people, and also jointly crackdown with PTA against such a franchise who activate SIMs fraudulently. PTA is the authority to monitor such activation of SIMs proactively.

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) It is submitted that sanitation directorate has stopped operation for elimination of stray / pie dogs in Islamabad ICT in compliance with the orders of Islamabad High Court in Writ Petition No 1155/2019 conveyed by The Chairman, Islamabad wild life Management Board, Ministry of Climate Change vide Letter No L2012WMB dated 17-06-2020

Previously Sanitation Directorate, MCI was taken action against stray / Pie dogs to avoid / control spread of rabies in Islamabad as per clause No. 89, Chapter - X, of ICT Municipal Bye Laws 1969.

16. ***Mr. James Iqbal:**

Will the Minister for Interior be pleased to state the number of trees removed to construct and widen the roads in Islamabad during the previous three years?

Minister for Interior (Mr. Ijaz Ahmad Shah): It is stated that 200 Nos. different if species trees were removed from Urban Division-I Environment Directorate (East), MCI during dualization of Atta Turk Avenue (West) from Khayaban-e-Suharwardy to Jinnah Avenue, Islamabad during the last three years. Although against these trees, almost 2500 Nos. new large size plants have been planted at said avenue.

17. ***Mr. Naveed Aamir Jeeva:**

Will the Minister for Interior be pleased to state:

(a) *whether it is a fact that CDA has issued NOC to Bahria Enclave, Islamabad a Housing Project of Bahria Town; if so, the details thereof;*

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) Layout plan of Bahria Enclave Housing Scheme sponsored by Bahria Town (pvt.) Ltd., in Mouza Malot was approved over an area measuring 836.40 Kanals comprising 589 residential plots on 16-07-2011. The Layout plan was cancelled on 02-07-2013 due to non-compliance of post LOP formalities and start of development work without issuance of NOC. The sponsor has submitted revenue papers over an area measuring 13500 Kanals and a public notice has been published in the daily newspaper on 25-09-2020 for inviting public objections regarding land status.

(b) As, the NOC for Bahria Enclave is not issued yet, the Bahria Town is not advertising the project for marketing.

(c) The total land of Bahria Enclave submitted for NOC is 13500 Kanals.

(d) CDA does not maintain the record of allottees of private housing scheme.

(e) As Bahria Town is a private Ltd. company, matter is not related to CDA.

(f) The Bahria Enclave has submitted LOP for NOC to CDA and is under process. However, as explained above the excessive booking of plot is not related to CDA, please.

18. ***Mr. Murtaza Javed Abbasi:**

Will the Minister for Interior be pleased to state:

- (a) *whether Deputy Commissioner, Islamabad being a Registrar of Housing Societies in the administrative jurisdiction of the capital, has taken notice of non-providing of possession of plots to its members, in particular allotment made against the Membership No.25/RMSA(30X60)JG-I/2016 dated 22nd June, 2016 and Membership No.77/MSA(30X60)JG-I/2016 dated 3rd June, 2016 of Federal Employees Cooperative Housing Society, Islamabad despite full amount of their plots is paid; if so, the details thereof;*

27. ***Mr. Muhammad Riaz:**

Will the Minister for Interior be pleased to state the total number of olive plants planted by CDA in Islamabad during last one and half year alongwith the locations thereof and the amount spent thereon?

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) Environment Wing of CDA has been devolved to Metropolitan Corporation Islamabad. Plantation in city is carried out as per landscape plans, prime importance given to esthetics and ornamental plants. Olive trees have not been planted during last one and a half year in Islamabad city. However same plants were planted in Margallah Hills National Park (NP) area in past. MHNP is potential site for panting these trees for which the experts from NARC are being consulted. On advice of the experts the plants will arranged from 1.4 NARC or other Government Institution involved in production of exotic olive species which will be planted.

28. ***Mr. Sher Akbar Khan:**

Will the Minister for Interior be pleased to state:

- (a) *whether it is a fact that road from Rawal Chowk to Taramri Chowk is in extremely dilapidated condition and accidents occur on daily basis in many numbers;*
- (b) *what steps are being taken by the Government to carpet the said road;*

To avoid accidents speed breakers are constructed and to resolve the traffic issues, U Turns / Fish Bellies are provided.

(b) The estimate for re-carpeting of the park road has been prepared for approval and allocation of funds is underway.

(c) Maintenance of Lehtrar Road from PINSTECH to Khanna Bridge is under Jurisdiction of Punjab Highway

(d) Maintenance of Lehtrar Road from PINSTECH to Khanna Bridge is under Jurisdiction of Punjab Highway

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) No, it is not fact that no employee come to cut extra grass / wild vegetation in street No.49, G-10/3. Extra grass / wild vegetation is being cleared on regular basis outside the houses of said street and from green belts. However, during Monsoon season growth of grass and wild vegetation increases ten times more than during the other seasons. Hence, keeping in view complaints of general public regarding cutting of extra grass / wild vegetation, during monsoon extra staff is deputed for cutting extra grass / wild vegetation from this area.

(b) In this regard, it is submitted that Environment Directorate is only responsible for plantation in streets and green belts. However, tree plantation inside the houses is responsibility of the owner of the houses.

5. **Mr. Abdul Qadir Patel:**

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) Hair Saloons and Beauty Parlors are registered by Directorate of Municipal Administration under ICT Municipal Bye Laws 1960, amended 2003 for registration of Hair Saloon and Beauty Parlors by inclusion of Hepatitis and AIDS in the Chapter: Infectious Diseases. According to information received from Director DMA, following data is shared.

- * Total registered Beauty Parlors and Hair Saloons in municipal limits of Islamabad: 49

- * Total Beauty parlors in G-10/3 (Khan and Shirazz Market) 01, Maya Beauty Parlor, Khan Market.
 - * Number of Notices issued: 01 on 27-7-20.
 - * Fine imposed: Fine is imposed by Magistrate First Class, CDA after issuance of challan.
- (b) Islamabad Health System is looked after by 02 Health Departments.
- i. DHS under MCI for sectoral areas within municipal limits demarcated by CDA.
 - ii. DHO Office, MoNHSRC for rural, suburban and peri-urban areas. Beauty Parlors and Hair Saloons are inspected routinely for checking hygiene of staff, equipment and environment. They are directed to undergo medical test examination BY Lab of DHS MCI and resultantly each staff is issued certificate of Fitness based on Hepatitis B and C tests

AIDS Test is not conducted by DHS as objection was raised by National AIDS program in 2002 which is the only program allowed to conduct AIDS tests and keep record of AID patients in Pakistan.

Details:

- * Medical test done (Hep B and C): Maya Beauty Parlor has been issued Notice on 27-07-2020 for undergoing medical examination and conducting vaccination of the staff. Parlour has been given a week time after which the Parlour has been re-inspected on 04-08-2020. The Owner of saloon did not comply with observation of the notice. Therefore, the said beauty saloon has been served with a challan.

- (c) * Fine imposed: 0

Reason:

- i. Fine is imposed by Magistrate First Class, CDA after issuance of challan.

- ii. DHS has 02 male Food Inspectors who are also checking hair dressers and Beauty Parlors. Keeping in view rising population of Islamabad, upon request of DHS. DHS was temporarily attached 02 Sanitary Inspectors from Sanitation Directorate as Food Inspectors to support food staff of DHS in December 2018. Since beauty parlors are being run by ladies and their clients are also ladies therefore their internal checking is difficult under prevailing social conditions.

2. The Government of Punjab is issuing wheat from Government reserves since July 9th 2020 to the ICT/Rawalpindi flour mills @Rs.1475/40kg. The rate of Atta produced from government wheat is Rs.860/20kg. The wheat is being issued to the flour mills of ICT @17.50 bags per body which becomes 9,502 bags of 100kg. The total working roller bodies in ICT Islamabad are 533.

3. The Aata is also sold which is produced from private wheat. The private wheat rate at present is Rs. 2250/- per 40kgs. The Aata produced from private wheat is packed in 15 kgs bags and its prices is not fixed. At present its retail price is Rs. 965-970 per 15 kgs bags.

4. Both packing of Aata i.e. 20kgs from Government wheat and 15 kgs from Private wheat is available in the markets of Islamabad.

Minister for Interior (Mr. Ijaz Ahmad Shah): (a) According to fresh survey, 14 stalls of bricks, sand and concrete are setup alongwith Service Roads of Sector I-9 and I-10.

— Three (03) have been given temporary permissions by Municipal Corporation Islamabad (MCI) while 11 stalls have restraining orders from courts.

(b) Yes, such nature of sand, concrete and bricks stalls exist in other parts of Islamabad however, in the wake of recent operations, CDA has removed such stalls from the area of Sector G-7, G-8 and G-9 except those whose cases are pending before the courts.

— The sites got vacated from these stalls, have also been handed over to Environment Wing, MCI for proper landscaping and plantation.

(c) Three (03) stalls have been permitted by MCI while remaining stalls have not been removed on account of pending litigation before the civil court:-

- (vi) Manzoor Ahmed and others Vs CDA etc

— Furthermore, CDA has been taking action against its own employees involved in such illegal activities. 04 officials have been suspended. Enquiries against suspended officials are in progress.
