Bidding documents, containing detailed terms and conditions, method of procurement, procedure for submission of bids, bid security, bid validity, opening of bids, evaluation criteria, clarification/rejection of bids, performance guarantee, etc. are available for the interested bidders at the websites of the National Assembly Secretariat ([www.na.gov.pk](http://www.na.gov.pk)), EPADS (<http://eprocare.gov.pk>) and PPRA's ([www.ppra.org.pk](http://www.ppra.org.pk)) free of cost.

3. The bids prepared in accordance with the instructions in the bidding documents, must be uploaded by using EPADS on or before **18<sup>th</sup> December, 2025 at 11:00 am**. Manual bids, shall not be accepted. Bids will be opened on EPADS on the same day at **11:30 am**.

## INTRODUCTION

The National Assembly Secretariat, Islamabad intends to pre-qualify reputable, experienced and technically sound firms/companies for service, repair and maintenance of various Machinery Equipment, Furniture/Fixture, Hardware, Software & IT Equipment on need basis initially for a period of TWO years, extendible for a further period of one year with mutual consent.

### 2. SCOPE OF WORK

- a) Service, Repair and maintenance of the equipment/items listed at Annexure-A as and when required.
- b) Replacement of defective parts with genuine parts.
- c) Periodic servicing to ensure smooth operations.
- d) On-site troubleshooting and technical support.

### 3. GENERAL TERMS AND CONDITIONS:

- a) The bidder must be NTN/GST registered and listed on the Active Taxpayers List (ATPL) of FBR.
- b) The bidder is required to submit their bids on EPADS Portal, manual/hard copies will not be accepted.
- c) Single Stage One Envelope bidding procedure as specified in rule 36(a) of the Public Procurement Rules, 2004 shall be followed.
- d) The deadline for uploading bids is 18<sup>th</sup> December, 2025 up to 11:00 a.m. The Bids will be opened through EPADS on the same day at 11:30 a.m. in the National Assembly Secretariat.
- e) A bid security of PKR 100,000 (Rupees one hundred thousand only) in the shape of a Bank Draft/CDR (Cheque will not be accepted) in favor of Section Officer (Procurement), National Assembly Secretariat, Islamabad, must be attached with the proposal.
- f) Firms that are willing to establish their setup in Islamabad/Rawalpindi may also apply; however, they are required to submit an affidavit affirming their commitment to establish the said facility in the twin cities.
- g) For pre-qualification, firms having experience, capability and resources may apply along with the following information and documents:
  - a) Name of firm along with postal address, email, phone & fax numbers
  - b) Three years of experience of rendering similar nature of works in the Govt, Semi Govt, Autonomous Departments.
  - c) Pre-qualified for similar nature of works with Govt, Semi Govt, Autonomous Departments along with names and address of clients
  - d) List of key personnel & detail of technical staff
  - e) Affidavit for non blacklisted/involved in arbitration/litigation
  - f) Annual turnover of Rs. 10 million during the last 3 years (income tax/Sales tax returns or audit reports must be attached).
- h) The firms will be shortlisted as per PPRA Rules, 2004
- i) Successful firms shall be responsible to provide its services for repair/maintenance after approval of their quotation.
- j) The pre-qualified Firms/Workshops shall be bound to carry out the requisite work on immediate basis after approval of their quotations and issuance of work order even at odd hours/public holidays.
- k) Firms shall preferably make it possible to rectify the fault of certain mechanical problem at the spot otherwise at workshop at their own arrangement.

- l) Firms shall be bound to replace the faulty parts with genuine spare parts having sufficient warranty period.
- m) Firms shall be bound to return the faulty parts to the National Assembly Secretariat, Islamabad.
- n) In case of arising of same fault within the warranty period, the firm shall replace the faulty part without any charges.
- o) The firms shall be pre-qualified on category-wise basis. The top three firms securing the highest scores in each respective category will be declared pre-qualified for that category. Interested firms may apply for one or multiple categories; however, they must clearly specify the categories for which they intend to participate. In case of specialized machinery equipment, the procuring agency would pre-qualify less than 3 firms, if deemed appropriate.
- p) Only pre-qualified firms/companies/workshops will be eligible to do business with National Assembly Secretariat during the tender period.
- q) The National Assembly Secretariat reserves the right to allow/reject wholly or partially any proposal or cancel the pre-qualification process altogether at any stage under the Public Procurement Rules, 2004.
- r) Conditional, incomplete, non-compliant bids will not be accepted.
- s) The National Assembly Secretariat expects that aspirant vendors should furnish all the required documents to ensure a transparent and genuine presentation. Therefore, it is necessary to upload the Tender documents meticulously by attaching required supporting documents according to the requirements and order as given in the eligibility criteria.
- t) The Procuring Agency can relax any term and condition stipulated in the tender document, including pre-qualifying criteria, where deemed appropriate, in the best interest of the Procuring Agency that doesn't alter the tender altogether or violate Public Procurement Rules, 2004.
- u) **All prospective bidders must visit the National Assembly Secretariat before submitting their bids to inspect and verify the equipment listed at Annexure-A, ensuring accurate and compliant technical proposals. However, bidders must provide prior intimation of the visit, along with the names and CNIC numbers of the visiting personnel, at least one day in advance.**
- v) The firm may contact the Section Officer (Procurement), National Assembly Secretariat, for any clarification/query before submission of bids. Clarifications of the bidding documents may be requested in writing through EPADS up to three days prior to the deadline for the submission of bids.
