RESOLUTION

Khawaja Muhammad Asif, Minister for Defence, moved the following resolution which was adopted by the House:-

وزیر برائے دفاع (خواجہ محمد آصف): اس ایوان کی رائے ہے کہ ایک سیاسی جماعت اور اس کے چیئرمین نے 9 مئی 2023ء کو آئین اور قانون کی دھجیاں بکھیرتے ہوئے ملک کی سلامتی کے حامل اداروں کے خلاف کارروائیوں میں تمام حدود و قیود عبور کرتے ہوئے فوجی تنصیبات پر حملے کئے۔ اس جماعت اور اس کے سربراہ کے اقدامات سے ملک، ریاست اور ریاستی اداروں کو ناقابل تلافی نقصان پہنچا جس کے تمام شواہد موجود ہیں۔ لہذا ان کے خلاف آئین اور قانون کے مطابق ایک دن کی بھی تاخیر کئے بغیر کارروائی مکمل کی جائے۔ اس جماعت اور اس کے سربراہ کی پاکستان دشمن کارروائیوں کا بوجھ اس کی اپنی جماعت کے رہنما اور کارکن بھی اٹھاپا رہے اور ان سے لا تعلقی کا اظہار کر رہے ہیں۔ جس سے اس امر کی توثیق ہوئی ہے کہ اس جماعت اور اس کے سربراہ کا ایجنڈا ملک دشمنی پر مبنی ہے۔ یہ ایوان قرارداد پیش کرتا ہے کہ شریکین اور مجرم عناصر کے خلاف کارروائی کے دوران کسی قسم کی انسانی حقوق کی خلاف ورزی نہیں کی گئی اور اس حوالے سے ایک سیاسی جماعت کے الزامات پر وپیگنڈا، لغو، جھوٹ اور بہتان بازی پر مبنی ہیں اور ان میں کوئی صداقت نہیں ہے۔ چونکہ پوری دنیا میں فوجی تنصیبات پر حملہ کرنے جیسے واقعات میں ملوث افراد کے خلاف کارروائی کرنے کا اختیار وہاں کی افواج کو میسر ہے تو پاکستان میں بھی ایسے عناصر کے خلاف قانونی اور آئینی تحفظ حاصل ہے۔ لہذا ان واقعات میں ملوث تمام افراد کے خلاف پاکستان آرمی ایکٹ 1952 کے تحت بلا تاخیر کارروائی مکمل کر کے سزا دلوائی جائے۔ شکریہ۔
