
REVISED NOTICE

(Change in composition)

In continuation of this Secretariat's Notice of even number dated 13th May, 2025, it is informed that 8th meeting of the Standing Committee on **Information and Broadcasting** will be held as per schedule i.e. **29th May, 2025 at 11:00 a.m. in Committee Room of Pakistan Television Headquarters, Islamabad**, to discuss the following agenda, however, the composition of the Committee has been revised:-

- i. Confirmation of the minutes of 7th meeting of the Committee held on 4th March, 2025;

 - g. PTVC's Pension Management system, monthly amount payable to the pensioners and current state of payment of pensions;
 - h. Outcome of the inquiry into the theft of containers from PTV Academy;
 - i. Internal Complaint Committee to address complaints on Harassment on workplace, its composition, meetings held till date, decisions taken and details of pending complaints, if any;
 - j. Delay in allotment of plots to the Journalists in Sector F-14-15 and Bara Kaho under quota for Journalists in schemes under FGEHF;
- iv. Presentation of Report of Sub-Committee appointed under the Convenership of Ms. Mehtab Akbar Rashdi, MNA on "The Pakistan Electronic Media Regulatory Authority (Amendment) Bill, 2024"; and
- v. Any other item with permission of the Chair.


