

5th meeting of the Standing Committee on **Cabinet Secretariat** will be held on **24th September, 2025 at 11:00 a.m. in Constitution Room, 2nd Floor, Parliament House, Islamabad,** to discuss the following agenda: -

 - ii. Comprehensive report/ implementation status of the previous recommendations of the Committee;
 - iii. Briefing by Oil and Gas Regulatory Authority (OGRA) on:
 - a. Performance of OGRA as Regulator of downstream petroleum and gas sectors.
 - b. Pricing Mechanism of Petroleum products.
 - c. Stockholding policy for Oil Marketing Companies (OMC) and OGRA's enforcement mechanism.
 - d. Actions taken by OGRA against non-complaint OMCs in terms of stockholding.

 - i. Regulation of Sui Gas Companies, tariff determination mechanism, action against them for not complying with the performance standards, infrastructure development and reduction of transmission/distribution losses.
 - j. Circular debt of Petroleum and Gas sector and measure taken for its mitigation;
 - k. Consumer Complaints Resolution mechanism and action taken against Companies overcharging their consumers, not-following billing cycles and conducting loadshedding beyond approved schedule.
 - l. Provision of RLNG connections, and tariff, thereof after decision of the Government to lift ban on new gas connections for domestic sector.
 - m. Way forward to deal with the gas connection applications backlog.
 - iv. To discuss "The Service Tribunals (Amendment) Bill, 2025" moved by Mr. Sohail Sultan, MNA; and
 - v. Any other item with permission of the Chair.
