 - 9) In pursuance of the complaint lodged by Sardar Nabeel Ahmed Gabol, MNA, the Chairman NADRA, Islamabad, to brief the Committee on the irregular and unauthorized issuance of CNICs/MNICs to non-entitled individuals (Bengali nationals) by NADRA officers in Karachi, with particular emphasis on the following points:
 - a) The serious irregularities involving the use of fake MNICs, forged death certificates, and fabricated supporting documents that were used to manipulate and facilitate the processing and approval of citizenship documents through TID 505441608741, VTS ID 13130002410, and TID 103331099502 (used to intrude into the family tree associated with CNIC 42101-1951184-1 and TID 505491722574);
 - b) The issuance of CNIC 42401-8871527-4 on the basis of forged documents;
 - c) Whether NADRA's internal SOPs differ from or override the national identity and citizenship policies of the Ministry of Interior and Narcotics Control;
 - d) Provide details, if any, of the disciplinary actions taken against NADRA employees in Karachi; and
 - 10) Any other item with permission of the Chair.
