NOTICE

4th meeting of the **Sub-Committee** of the Standing Committee on the **Power Division** will be held on **the 04th March, 2026 at 03.00 p.m. in Committee Room No. 7 (4th Floor), Parliament House, Islamabad** to consider the following agenda in accordance with its Terms of Reference (ToRs), as detailed below:

- (1) To examine the causes of prolonged faults in field operations arising from the non-availability of maintenance materials and to assess their impact on public trust and service delivery.
- (2) To inquire into the non-installation of new transformers in HAZECO and to assess its implications for effective management of peak summer load demand.
- (3) To scrutinize the utilization of financial resources by HAZECO, particularly expenditures on new vehicles and officer accommodations, and to ascertain the reasons for non-allocation of funds to field operations during the past year.
- (4) To examine the allocation and utilization of newly procured vehicles by HAZECO, including their retention at head office, the non-availability of transportation and fuel for field staff, and the resulting public dissatisfaction.
- (5) To examine the non-functionality of essential departments, including Planning, PMU, Commercial, CM&O, Safety, and Administration, during the past year, and to assess its impact on unresolved industrial connections, shift of industries to solar energy, and the consequent loss of HAZECO's goodwill.
- (6) To assess the requirement and feasibility of allocating at least three vehicles for field operations, including one each for Hazara-I Circle, Hazara-II Circle, and Hazara Division, to ensure effective service delivery.
- (7) To examine the need for ensuring the availability of a dedicated vehicle at all times for prompt redressal of public complaints.
- (8) To review HAZECO's load-shedding schedule with a view to limiting it to a maximum of four hours, assess the prioritization of strengthening field operations over new building investments, and ensure timely conduct of promotion and up-gradation boards for employees and officers.
- (9) To direct HAZECO to furnish, within two days, a cadre-wise list of employees transferred from other entities, such as GENCOS, along with their current designations in HAZECO.
- (10) To examine the issue of staff shortage in HAZECO, identify feasible solutions, and assess the effectiveness of appointing new officers, acquiring vehicles, and constructing new infrastructure in the absence of adequate manpower.
- (11) To investigate the reasons for relocating the 132KV Grid Site from the load center at Padhana to a less feasible location and to assess the technical, operational, and planning justification for this decision.
- (12) To ascertain the commencement date for DOP and ELR works, specifically KTS-2, which was approved and funded by PESCO but subsequently surrendered by HAZECO, and to examine the reasons for such surrender.
