


NOTICE

24th meeting of the Standing Committee on **Federal Education and Professional Training** will be held on **Monday, the 6th July, 2026 at 11:00 a.m. at Committee Room No. 7 (4th Floor), Parliament House Islamabad,** to discuss the following agenda: -

- (6) faculty related issues at the Federal Urdu University of Arts, Science and Technology, Abdul Haq Campus Karachi and measures for the solution; and
- (7) any other item with the permission of the Chair.
