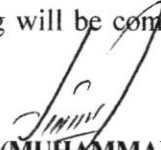

2. The new date and time of the postponed agenda / meeting will be communicated in short notice.

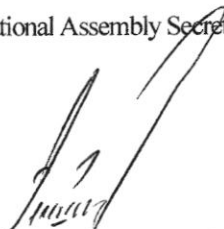
