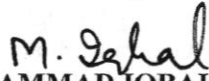

REVISED NOTICE
(Inclusion of Agenda item No. vi)

In continuation of this Secretariat's Notice of even number dated 28th August, 2026, it is hereby informed that 18th meeting of the Standing Committee on Railways will be held as per its scheduled i.e; on **Monday, the 7th September, 2026, at 11:30 a.m. in Committee Room No. 7 (4th Floor), Parliament House, Islamabad.** However, the agenda item No. vi for the meeting has been included in following agenda:-

- (vi) briefing on the return of Welfare Projects to Pakistan Railways Police; and
- (vii) any other item with permission of the Chair.

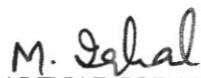
