### **NOTICE**

29<sup>th</sup> meeting of the Standing Committee of the National Assembly on the Ministry of **Interior and Narcotics Control** will be held on **Thursday, the 03<sup>rd</sup> September, 2026 at 02:00 p.m., in Constitution Room (Old Committee Room No. 5), 2<sup>nd</sup> Floor Parliament House, Islamabad** to consider/discuss the following Agenda:

- (1) Confirmation of minutes of the previous meeting held on the 10<sup>th</sup> July, 2026;

    - iii) State Bank of Pakistan (SBP) to explain the policy on commercial banks to prevent unauthorized withdrawals/transfers from bank accounts through scams, along with steps taken to safeguard public money.
  - (7) Briefing by the Director General, National Cyber Crime Investigation Agency (NCCIA), Islamabad on the following points:
    - i) Provide details regarding Cyber Crime cases registered by NCCIA during the last two years;
    - ii) Number of cases disposed off and amounts returned to the affectees/victims;
    - iii) Number of cases pending and reasons for the delay; and
    - iv) Explain the legal position about the punishment of scam criminals.
  - (8) Briefing by the Inspector General of Police, Islamabad on the current law & order situation, Safe City Project and frequent use of drugs in Islamabad Capital Territory (ICT);
  - (9) The Chairman, Capital Development Authority (CDA), Islamabad to brief the Committee on the present status of Islamabad Master Plan; and
  - (10) Any other item with permission of the Chair.
