to seek a detailed briefing from the Workers Welfare Fund and other concerned departments regarding the operational modalities and welfare of mine workers, particularly in the wake of the recent tragic incident in Balochistan in which several mine workers lost their lives with particular reference to whether the affected mine workers were duly registered with the Employees' Old-Age Benefits Institution (EOBI) and the Workers Welfare Fund or any other entity; the prescribed safety measures laid down by the Workers Welfare Fund and the respective Provincial Government were duly implemented; the relevant departments had carried out the requisite inspections of the mines; and the existing mechanism for ensuring the welfare, safety, registration, and social protection of mine workers; and
 - (6) any other item with permission of the Chair.
