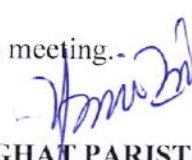
REVISED NOTICE

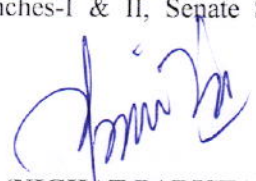
