38. **\*Rana Sana Ullah Khan:**

*(Deferred during 6th Session)*

*Will the Minister for Interior be pleased to state:*

- (a) the terms and conditions of the agreements between the Government and the protesters made on 31-10-2018 and 2-11-2018;*
- (b) the total number of cases registered against the protestors;*
- (c) the details of damage caused by protestors; and*
- (d) whether any compensation has been paid to injured and dead and those who suffered property loss alongwith the details; if not, the reasons therefor?*

Deferred for answer on Next Rota Day.

*(Deferred during 9th Session)*

*Will the Minister for Interior be pleased to state:*

- (a) whether it is a fact that almost 300 children could not be operated in CDA Hospital, Islamabad due to non availability of funds for Cochlear Implant Surgery of special children;*

(b) *if so, the steps being taken by the Government to resolve the said issue?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) Yes, it is a fact that almost 300 children could not be operated in Capital Hospital due to stoppage of funds from the Federal Government.

Cochlear Implant Surgery for Special children was the initiative of the Federal Government. All cases were referred by Prime Minister's Grievances Wing, Ministry of Parliamentary Affairs.

As the Capital Hospital could not entertain any direct case, funds were being provided through Ministry of National Health Services, Regulation and Coordination after approval from the Prime Minister's office on case-to-case basis.

(b) Capital Hospital is a Departmental Hospital working under the administrative control of Capital Development Authority, being an autonomous body. The Hospital provides medical facility only to its employees and their dependents. As CDA Medical Attendance Rules have no provision to run such programs for general public, accordingly, after stoppage of program due to non-provision of funds by the Federal Government, the issue was raised by CDA Hospital in the following meetings/ briefings called for the purpose:

- (i) Briefing to the Minister for National Health Services, Regulation and Coordination, dated 19-02-2018.
- (ii) Meeting with Managing Director, Pakistan Baitul Mall, dated 27-11-2018.
- (iii) Briefing to the Minister for State, Prime Minister's Grievances Wing, Ministry of Parliamentary Affairs, Islamabad, dated 29-11-2018.
- (iv) Briefing to the Special Assistant to Prime Minister on CDA Affairs, dated 30-11-2018.

*Will the Minister for Interior be pleased to state the implementation status on National Action Plan?*

1. **\*Ms. Tahira Aurangzeb:**

*Will the Minister for Interior be pleased to state whether plants have been planted in Prime Minister's House and Punjab House, Islamabad under Islamabad green and clean campaign; if so, the number and names of said plants?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** No plants have been planted by Metropolitan Corporation and ICT in Prime Minister House and Punjab House under Green and Clean Pakistan campaign as the Horticulture work of Prime Minister's House and Punjab House, Islamabad is being looked after by Pak-PWD and Punjab House Staff respectively. However, Director Horticulture Pak. PWD has reported that 70 Nos. Pine Plants have been planted at Prime Minister's House under clean and green campaign by Pak. PWD whereas 30 Nos. Pine Plants have been planted at Punjab House by Horticulture Staff of Punjab House.

2. **\*Mr. Ali Gohar Khan:**

*Will the Minister for Interior be pleased to state:*

- (a) *the steps taken by the Government to eradicate the corruption and bribery by agent mafia in Passport Office, Faisalabad; and*
- (b) *the steps being taken to check the employees abetting the agent mafia alongwith the names and designations thereof?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) Following steps have been taken by the Department of Immigration and Passports to eradicate corruption and bribery of the agent mafia at Regional Passport Offices across the country including Regional Passport Office, Faisalabad:

- i. All DC's / DPO's have been requested to take necessary action for removal of agents / touts from within a radius of 1 Km of the premises of Regional Passport Offices and Section-144 of Cr. PC may be imposed around the vicinity of Regional Passport Offices to stop activities of tout mafia and curb this menace.
- ii. Following FIRs have also been registered by Incharge, Regional Passport Office, Faisalabad, against touts / agents sitting outside the offices on account of cheating / deceiving and looting the passport applicants:—

- iii. Following initiatives have also been taken by Officer Incharge RPO Faisalabad:
  - a. Removed benches of agent/touts from out side the passport office permanently.

- b. Installation of CCTV Cameras outside the passport office to keep strict eyes on the movement of agents / touts roaming outside the building.
  - c. Entry of Un-authorized persons is totally banned.
  - d. Installation of barbed wire around the passport office.
  - e. Officials have been directed to switch off their mobile phones during office hours just to rule out the possibility of contact with any unauthorized person.
- iv. All Zonal Heads have also been directed to pass following instructions to concerned Regional Passport Offices of their respective Zones to:
- (a) Take stern action against touts / agent mafia in liaison with local administration for curbing corrupt practices.
  - (b) Strictly follow SOPs as per Passport & Visa Manual 2006 in issuance of Passports to the applicant.

(b) All Zonal Heads as well as Officer Incharge of concerned Passport Offices has been directed to warn staff in writing that whosoever found in illegal practices and abetting the agent / touts mafia, would be liable to strict disciplinary action.

3. **\*Dr. Shazia Sobia Aslam Soomro:**

*Will the Minister for Interior be pleased to state:*

- (a) *whether it is a fact that the amount of 1.7 billion rupees has been embezzled in Jammu and Kashmir Co-operative Housing Society; if so, whether the same has been recovered; if not, the reasons for not recovering the same so far;*
- (b) *the persons to whom 868 kanal recovered land was allotted and the procedure of the allotment; and*
- (c) *the reason for not clearing the payment of G-15/4 pockets out of the recovered amount?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) No. the embezzlement to the tune of 1.7 billion rupees has been pointed out by the auditors in the annual audit of the society which is regularly conducted each year. However, it is stated that on the direction of the supreme court of Pakistan, forensic audit of the society for the period of 1st July 2011 to 30th June 2016 is being conducted which is near completion. The report of the audit will be shared and if any embezzlement is pointed out, amount will be recovered and action will be initiated against the delinquents.

(b) Raw Land (undeveloped) measuring 868 Kanals was given to the society by six persons. The society in return allotted 303 Kanals developed plots on the formula which prescribe allotment of 35% of developed land against raw land. Details of the person and land allotted to each is as under:-

(c) As stated earlier no amount has been pointed out as embezzlement in any of the audit report and therefore, no recovery has been initiated. Secondly, land measuring 50 kanals is situated in Sector G-15/4, Islamabad which is under litigation, therefore, payment issue will be settled after conclusion of the case.

4. **\*Mr. Gul Dad Khan:**

*Will the Minister for Interior be pleased to state:*

(a) *whether ratio of crimes has been increasing in the Federal Capital Territory;*

(b) *if so, the details of the crimes, rape, kidnapping for ransom, car lifting, murder, dacoity, robbery etc. during the last one year and the steps taken to eradicate the said crimes?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) There is no increase in ratio of crime in Federal Capital rather 35.16 percent crime has been decreased for the last 06 months as compared to previous year.

(b) Detail of crime is as under:—

- Data Base (survey of Kachi Abadies)
- Intelligence Based Policing.
- Combing/ Search Operations.
- Random checking of Guest Houses/Hotel/Motel.
- General Hold-ups (Surprise checking)

- Survey of Rented Accommodation, illegal settlements & Deeni Madaris.
- Surveillance of suspected Elements.
- Data proofing of released prisoners.
- Monitoring through safe city cameras, please.

5. **\*Mr. Muhammad Hashim Notezai:**

*Will the Minister for Interior be pleased to state:*

- (a) *the steps taken, so far by NADRA, to make Computerized National Identity Cards (CNICs), issued to Afghan Refugees or foreigners, ineffective;*
- (b) *the steps taken, so far to cancel the fake Computerized National Identity Cards issued to the foreigners in Balochistan alongwith the numbers thereof; and*
- (c) *the steps taken by NADRA to make sure that CNICs may not be issued to Afghan Refugees, and other foreigners?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) CNICs are issued to Pakistani Citizens only. If some foreigner is able to acquire CNIC through forged documents or through falsification, then his/her card is cancelled. The following steps have been taken in this regard:—

- **9,554** x cards cancelled
- **121,117** x cards blocked on doubtful National Status.
- CNIC is issued only once the data (Photo/thumb impression) is cross matched against Afghan issued cards/Aliens Registration cards.
- All doubtful National status cases reported by any Verifying Agencies are blocked at once.
- **120** x employees have been dismissed/terminated from NADRA on account of issuance of CNIC to non-nationals.

(b) In Balochistan, **22,072** x cards are digitally impounded on account of suspect National Status.

- All these cards will be cleared/cancelled only, once the report of District Level Committee (DLC) constituted by Ministry of Interior is received.
- So far, **1,450** x cards have been cancelled from Balochistan on receipt of DLC report.

(c) Stringent but practicable Registration SOPs issued to all NADRA's Centres for issuance of CNICs.

- Regular training is imparted to the Registration Staff so that NADRA's employees remain abreast with latest changes.
- Where National Status of the applicant is found doubtful, there are asked to provide documents in the light of Ministry of Interior Notification # 8/37/2016-NADRA dated 19-04-2017.
- Each CNIC application is cross-matched through biometric alien watch list prior to issuance of CNIC.
- To curb the tendency of intrusion of non-nationals in genuine families, system of biometric verification of blood relative has been introduced along with interview through which significant impact has been achieved.

**Minister for Overseas Pakistanis and Human Resource Development:** The names of the Labour Attaches (Community Welfare Attaches) posted abroad with their experience, name of the country and grade are at **Annex-A**.

- (a) *whether it is a fact that problems are multiplying due to street hawkers/eatables sellers on carts in every street/Mohallah at present; and*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) Yes.

(b) There is no such proposals under consideration to get registered the hawker passes at union council level in Islamabad.

8. **\*Mr. Saleh Muhammad:**

*Will the Minister for Interior be pleased to state:*

- (a) *the areas of Islamabad, including rural areas and Sector G-11/2, dotted with encroachments and the steps being taken by the Government in this regard;*
- (b) *whether it is a fact that in Sector G-11/2, Islamabad, the encroachments, like Iron fences/car porches, in front of various homes, are increasing which makes people, movement difficult; and*
- (c) *the time by which the Government will remove such encroachments for public welfare alongwith the details thereof?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a)

- A special drive has also been started to remove encroachments outside the residential houses and private buildings / offices.
- Initially, iron grills, fences, sheds etc got removed in the areas of Blue Area + Mauve Area + Margalla Road (Sector F-5 to F-11).

- This operation is in process and its scope will be further expanded to all residential areas of Islamabad and public pathways would be freed from such encroachments.
- Images are enclosed for ready reference.
- (b) — It is a fact, these encroachments are creating nuisance for pedestrian movements however, further expansion has been curtailed by strict surveillance particularly in Sector G-11/2.
- (c) — Market & Road Maintenance is role of MCI however, CDA has initiated action to clear areas in Islamabad.
- It is expected that this would be removed within a period of four (04) months.

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) Details not available due to original record held under NAB Rawalpindi.

- (b) Same as above.

10. **\*Mr. Sher Akbar Khan:**

*Will the Minister for Interior be pleased to refer to the Starred Question No.23 replied on 22-04-2019 and to state:*

- (a) *the reasons for not implementing, so far, the letter No. 1173/CR/ICT/B dated 13-3-2019, as mentioned in reply to part (b) of the said question with details; and*
- (b) *when was the forensic audit of the Jammu and Kashmir Cooperative Housing Society carried out alongwith date-wise number of meetings held so far, the names of officer who presided the same, the present stage of audit and the time by which it would be completed with details thereof?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) The referred letter states about constitution of election commission for holding election of the society. Meanwhile, the election process has started and voter list is being compiled and after finalization of the voter list, election schedule will be issued by the Registrar Cooperative Societies, ICT, Islamabad in June 2019.

(b) It is stated that on the direction of the supreme court of Pakistan, forensic audit of the society for the period of 1st July 2011 to 30th June 2016 is being conducted which is near completion. Furthermore, actions will be initiated in light of the recommendation of the audit report.

11. **\*Ms. Shamim Ara Panhwar:**

*Will the Minister for Interior be pleased to state:*

- (a) *the total number of employees recruited, in the Ministry and its each attached departments, during the present regime till date; and*
- (b) *the criteria and procedure of recruitment?*

12. **\*Moulana Abdul Akbar Chitrali:**

*Will the Minister for Interior be pleased to refer to the Starred Question No.10 replied on 15-01-2018 and to state:*

- (a) *whether the PC-I of the underpass at PWD Housing Society at Islamabad Expressway has been approved; if so, the details;*

- (b) *whether tender documents have been prepared by the consultants; and*
- (c) *the name of contractor to whom it has been awarded, dates of completion alongwith financial details thereof?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) No, it is clarified that separate PC-I has not been prepared/ submitted/ approved for underpass at PWD Housing Society at Islamabad Expressway. However, the subject underpass is included in the overall PC-I of Islamabad Expressway Signal Free Corridor from Karal Interchange to G. T Road, Islamabad which is still under process for approval by the ECNEC.

(b) Design/ estimation and draft tender documents has been prepared by the consultants; however tender documents will be finalized after approval of the PC-I by ECNEC.

(c) No work is awarded. The work will be awarded as per PPRA Rules after approval of PC-I from ECNEC, allocation and release of required funds by the Federal Government.

13. **\*Ms. Nafeesa Inayatullah Khan Khattak:**

*Will the Minister for Overseas Pakistanis and Human Resource Development be pleased to state:*

- (a) *whether it is a fact that under Article 270 AA-(6) of the Constitution, Bonded Labour System (Abolition) Act, 1992 is applicable in ICT;*
- (b) *if so, the steps taken by the Government for implementing the same since 2009 till 2019?*

**Minister for Overseas Pakistanis and Human Resource Development:** (a) Yes, it is a fact that under Article 270-AA (6) of the Constitution, The Bonded Labour System (Abolition) Act, 1992 is applicable in Islamabad Capital Territory (ICT).

(b) **The Government has taken the following steps:**

- i. A permanent mechanism for implementing the labour laws including bonded labour has been established by the administration of ICT.
- ii. The field staff of Labour Welfare Department of ICT regularly visits their respective areas for enforcement of labour laws. Furthermore, daily inspection of various factories, establishments and brick kilns is carried out by the field staff and strict legal actions have been initiated against violators.
- iii. During the period from 2009 to 2019, 13116 Challans were issued under different labour laws including bonded labour, which were forwarded to the concerned Court for legal proceedings.
- iv. The ICT administration has sealed 36 brick kilns operating in the jurisdiction of Sub-division Noon and 14 in Sub-division Saddar of Islamabad.

14. **\*Mr. Saleh Muhammad:**

*Will the Minister for Interior be pleased to state:*

- (a) *the name of company/firm that was awarded the contract of cleanliness in Parliament Lodges and Driver Canteen therein and since when this company/firm is working; and*
- (b) *the time by which steps will be taken, by the CDA, for bringing improvement in cleanliness in Parliament Lodges and Canteen?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) The work was awarded to M/s Fatima Constructions & Builders having ISO certification for cleanliness (Janitorial) works on dated 26-11-2018 for a period of one year *i.e.* upto 25-11-2019.

(b) Certificate of satisfactory execution of work is mandatory as per terms & conditions of contract and the same is obtained from Member Senate House Committee.

Tenders for canteen / cafeteria as per TORs submitted to the House & Library Committee shall be invited after approval of the same.

15. **\*Ch. Muhammad Barjees Tahir:**

*Will the Minister for Interior be pleased to state:*

- (a) *whether it is a fact that it is not the potential of Safe City Project cameras to get rid of street crimes, vehicles theft, purse snatching and child kidnapping in Islamabad from inside streets where no such cameras have been installed;*
- (b) *if so, is there any proposal of the Government to make it obligatory for the residents of Islamabad to have a joint (by house) security guard system from their own pockets;*
- (c) *if so, when it will be implemented;*
- (d) *if not, the alternate programme, Government has to overcome inside streets security issues?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) As per report of SP/Safe City, Islamabad, the Safe City project was established in Federal Capital to monitor the important building's entry / exit points, roads, commercial centres and sizable portion of the city's residential areas. However, after inauguration of this project, 1597 number of cases out of 3672 was identified through Safe City cameras.

(b) No such proposal is under consideration with ICT Police.

(c) -Do-

(d) To make Islamabad capital , a crime free city, the ICT Police took following steps as well as preventive measures to curb the crime / criminals generally and street crime specially:—

- Identification of crime pockets.
- Crime cluster Analysis.
- Establishment of Nakas.
- Data Base ( Survey of Kachi Abadies)
- Intelligence Based Policing.

- Combing/ Search Operations.
- Joint Patrolling with Pak. Rangers.
- Foot patrolling in the streets.
- Random checking of Guest Houses / Hotel/Motel
- General Hold-ups (Surprise checking).
- Survey of Rental Accommodations, illegal settlements & Deeni Madaris.
- Surveillance of suspected elements.

16. **\*Ms. Nafeesa Inayatullah Khan Khattak:**

*Will the Minister for Overseas Pakistanis and Human Resource Development be pleased to state:*

- (a) *whether any gender-based labour survey has ever been conducted by any Government agency during the last six years in order to assess the number of women and men involved in our labour force all over the country;*
- (b) *if so, its details indicating also the percentage share of both genders in different fields of economy like agriculture, mining, industry etc.?*

17. **\*Ch. Muhammad Barjees Tahir:**

*Will the Minister for Interior be pleased to state:*

- (a) *whether it is a fact that presence of Kachi Abadis in Islamabad is a challenge to the writ of law passed by the State;*
- (b) *if so, the reasons thereof and the action taken against the responsible thereof;*
- (c) *the reasons of presence of Kachi Abadis in Islamabad at present; and*

(d) *the time by which the Government will establish its writ in this regard?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) Yes the presence of Katchi Abadis (KA) in Islamabad is a challenge to the writ of law passed by the government, as the Katchi Abadis are human settlements on CDA's acquired land.

(b) The government of Pakistan has recognized ten Katchi Abadis for regularizations. All others are encroachment on CDA's land. Out of these ten Katchi Abadis, 2 Katchi Abadis (namely, Katchi Abadi HaqBaho and Dhoke Najju, Islamabad) have been completely rehabilitated in MODEL URBAN SHELTER PROJECT, FRASH, LEHTRAR ROAD, ZONE-4, ISLAMABAD. Remaining 8 Katchi Abadis are in the process of regularization (detail in material for supplementary). However on the directions of the government CDA is making a proposal to rehabilitate the dwellers of two Katchi Abadi (Katchi Abadi (KA) F-7/4 and KAF-6/2 to rehabilitate them in apartments within sectoral area of Islamabad. regarding other encroachments on CDA's acquired land, FIA has also conducted an enquiry.

(c) The reasons of presence of Katchi Abadis are weak development control on CDA's acquired land.

Due to establishment of Federal Capital adequate provision of housing could not be provided to accommodate the labor class.

(d) The Government is working on the issue by adopting following measures:

- Accommodating dwellers of recognized Katchi Abadis within sectoral area of Islamabad as well as MUSP, FRASH, Islamabad.
- Additionally proposal is being made to accommodate dwellers of Katchi Abadis within sectoral area of Islamabad in housing apartments.
- CDA has also proposed a human settlement Act.
- Since the issue relates to rehabilitation of human beings, as such it is difficult to spell out time regarding the subject matter, nevertheless Government is making all its effort to control the encroachments on CDA's land and rehabilitate the dwellers of recognized Katchi Abadis, accordingly.

Rs. 750/-and Rs. 2500/- are charged if an applicant desires to get Smart Card and executive services, respectively.

(b) All NADRA Offices in the country have been directed to process CNICs (Teslin based)/ Smart ID or Normal/Urgent/Executive) as per applicant's desire.

- Strict action is taken if any such violation is reported.

**Minister for Inter-Provincial Coordination (Dr. Fehmida Mirza):** Under Rules of Business, 1973, the Ministry of IPC has been performing secretariat work for CCI since 2010. Moreover, under the same Rules of Business, the Ministry has been entrusted the function of promoting uniformity of approach in formulation of policies and their implementation by the Provinces and the Federal Government in all fields of common national concern.

The Council of Common Interests (CCI) is a constitutional body setup under Article 153 of the Constitution. Under Article 154(1), the CCI formulates and regulates policies in relation to matters in Part II of the Federal Legislative List and shall exercise supervision and control over related institutions. Hence, the purview of CCI is confined to eighteen subjects enumerated in FLL Part-II.

Moreover, the Prime Minister has setup Inter Provincial Coordination Committee (IPCC). The Ministry has been instrumental in affecting coordination on several issues of national importance including (non-exhaustive).

So far, 40 meetings of CCI have been convened from 1973 to 2018 (29 meetings since 2010 to-date) and process for 41st meeting is in hand. During these meetings a number of issues of mutual interest between the federation and provinces were brought before the CCI for consideration of and decision. Major issues resolved by CCI were as under:—

- (i) National Energy (Power) Policy, 2013-2018.
- (ii) Power Generation Policy, 2015.
- (iii) Mechanism for at source deduction of outstanding power sector payables of Provinces.
- (iv) National Forest Policy, 2015.
- (v) Settlement of Net Hydel Profit (NHP) Issue between WAPDA and Punjab and KP.
- (vi) National Water Policy & National Water Charter.
- (vii) Formulation of National Flood Protection Plan-IV (2015-2025).
- (viii) Liquefied Petroleum Gas Production and Distribution Policy, 2015 .
- (ix) Supply of Gas to Localities / Villages in 5 KM Radius of Gas Producing Fields.
- (x) Implementation of Kazi Committee Methodology (KCM) for Calculation of Net Hydel Profit.

- (xi) At Source Deductions from Divisible Pool Share of Government of Khyber Pakhtunkhwa.
- (xii) Sixth Population and Housing Census.
- (xiii) Implementation and Amendments — Petroleum (Exploration and Production) Policy, 2012.
- (xiv) Development of Special Economic Zones (SEZs) under CPEC.
- (xv) Resolution of Energy Problems of Balochistan Province/ Enhancement of Absorption Capacity.

In addition to above, the Ministry of IPC has convened 27th meetings Inter Provincial Coordination Committee (IPCC) since 1992. Important issues resolved through IPCC are as under:

- Sixth Population and Housing Census
- Power Generation Policy 2015
- Oil & Gas Matters
- Financial Crunch Faced by Population Welfare Programme(s) in Balochistan
- Import of Liquefied Natural Gas(LNG)
- Supply of Gas to Localities/ Villages in 5 KM Radius of Gas Production Fields.

Besides above, the Ministry is engaged in following activities, in collaboration with the provinces:—

- A meeting of Provincial Tourism Ministers was convened to promote uniformity and better coordination on Tourism.
- A meeting of Provincial Ministers on Climate Change was also held to promote uniformity and enhance coordination with regard to Clean and Green Pakistan.

- Strengthening relations with China through friendship of sister and provinces cities. In this regard, three agreements/letter of Intent have been signed between Karachi-Urumqi, Gawadar-Puyang and Multan-Xian during the visit of Pakistani delegation to China lead by Minister for IPC including provincial representatives;
- Heavily engaged in revamping the existing sports system in Pakistan.
- Facilitating the implementation of Ehsas Program in provinces.

25. **\*Ms. Uzma Riaz:**

*Will the Minister for Overseas Pakistanis and Human Resource Development be pleased to state:*

- (a) whether it is a fact that under Article 38 (c) of the Constitution, EOBI has to provide compulsory social insurance to retired workers over 40 years in the shape of old-age pension;*

- (c) the steps presently taken by the Government to eradicate this issue?*

**Minister for Overseas Pakistanis and Human Resource Development:** (a) (i) According to Article 38(c) of the Constitution, the State shall provide social security by compulsory social insurance, or other means for all persons employed in the service of Pakistan or otherwise.

(ii) The EOB Act 1976 was enacted with effect from April 01, 1976, to achieve the objective.

It extends Old-Age Benefits to insured persons or their survivors. However, for Old Age Pension Section-22 of EOB Act, 1976 provides as under;

**22(1)** An insured person shall be entitled to a monthly old age pension at the rate specified in the Schedule.

**Provided that:**

- (a) he is over sixty years of age, or fifty five years in the case of a women; and  
(b) contributions in respect of him were paid for not less than fifteen years.

**Provided further** that the age specified in clause (a) will be reduced by five years in the case of an insured person employed in the occupation of mining for at least ten years immediately preceding retirement.

(b) After the 18th constitutional amendment, the following issues have been experienced in collection:

1. A number of employers have stopped payment of contribution due to legal position of EOBI after devolution.
2. Minimum Wages are announced by the Provinces instead of Federal Government and because of this contribution is being collected at the rate of Rs. 480/- per Insured Person/month on the basis of last minimum wages announced by the Federal Government *i.e.*, Rs. 8,000/- p.m. The collection should be Rs.900/- per Insured Person/month on the basis of current minimum wages, which is an administrative hurdle due to 18th constitutional amendments.

(c) At present the matter of devolution of EOBI is under consideration in the Council of Common Interests.

However, ICT Police with effective coordination of Local Administration took appropriate measures against the violators and saved the government / private properties and the people.

Brief detail of criminal cases and arrested / detained accused is attached at **Annex-A**.

(b) The ICT Police remained proactive throughout the current year and during the sit-in / dharna announcements of Tehreek-e-Labaik Pakistan strict legal action was taken against the accused persons involved in road blockade and protests. A brief detail of cases registered against accused and action taken against them is also attached in **Annex-A**.

(c) Creation of Law & Order Division in ICT Police.

437 posts for the Division has been created in Phase-I.

1015, 967 and 967 posts for Phase-II, III & IV is under process with MS Wing of Establishment Division and Finance Division.

Re-organization of office of IGP is under process.

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) NOC is not issued to National Cooperative Housing Society former Aiwan-e-Sadar Housing Society by CDA, even Layout Plan of the scheme is not yet to be approved by CDA because the access road to the scheme is less than 60' which should be 60 feet for Housing Scheme having area 400-700 kanals as per CDA Board Decision dated 9-6-2017.

(b) The information regarding allotment status of society pertains to the office of Deputy Commissioner/Registrar, Co-operative Societies, Islamabad Capital Territory Administration (ICT), Islamabad as it is responsible for Registration of society, Admin, and membership affairs, financial matters, elections, holding of Annual General Meetings (AGMs), Allotment/Auction of Plots, Annual Audit, etc. of Co-operative Housing Societies.

(c) The information regarding allotment status of society pertains to the office of Deputy Commissioner/Registrar, Co-operative Societies, Islamabad Capital Territory Administration (ICT), Islamabad as it is responsible for Registration of society, Admin, and membership affairs, financial matters, elections, holding of Annual General Meetings (AGMs), Allotment/Auction of Plots, Annual Audit, etc. of Co-operative Housing Societies.

9. **Moulana Abdul Akbar Chitrali:**

*Will the Minister for Interior be pleased to state:*

- (a) *the reason for non-issuance of No Objection Certificate (NOC), by the Capital Development Authority, to the Senate Secretariat Employees Cooperative Housing Society, Islamabad;*
- (b) *whether the said Housing Society fulfills the requirements for issuance of NOC; if not, the details thereof; and*

(c) *the time by which NOC will be issued to the said Society?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) Revised Layout plan of the Senate Avenue Housing Scheme, Mouza Herdogher, Zone-V, Islamabad sponsored by M/s Senate Employees Co-operative Housing Society (SECHS), Islamabad was approved by CDA on 23-9-2009 over an area measuring 680 Kanals and 569 residential plots. The Society was advised by CDA to complete the Pre-requisites for obtaining NOC from CDA, but management of the Society failed to do so. Thus NOC of the said scheme was not issued by the CDA and thus Sale/ purchase of plots and development in the scheme is illegal and unauthorized. As per Modalities and Procedures framed under ICT Zoning Regulation 1992 the sponsors of the scheme are allowed to advertise the scheme only after issuance of NOC. It has further been observed that Senate of Pakistan vide its advertisement dated 29-8-2016 appeared in daily Jang has disowned the society. The sponsors of the scheme have been directed to immediately stop the advertisement of the above said scheme and refrain from sale/purchase and booking of plots failin. which strict action shall be initiated.

(b) There is a dispute of access road between Senate Avenue Housing Society and Gulshan-e-Rabia Housing Scheme as access road of the scheme is crossing Gulshan-e-Rabia Housing Scheme for which layout plan has been withdrawn/ cancelled by CDA but land stands mortgaged and transferred with CDA.

(c) As soon as the Society completes the requirements of CDA and land dispute are resolved, CDA will process layout plan approved and NOC to the society.

10. **Ms. Shamim Ara Panhwar:**

*Will the Minister for Interior be pleased to state:*

- (a) *whether it is a fact that citizens are facing difficulties in traffic due to illegal parking by Car Dealers in Karachi Company (G-9 Markaz), Islamabad;*
- (b) *the steps being taken to remove illegal parkings and other encroachment in Karachi Company, Islamabad;*

(c) *the time by which the illegal parkings of car dealers will be removed; and*

(d) *the name of dealers and the number of vehicles parked?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) Yes.

(b)- During the recent operation conducted on 20.05.2019, following car showrooms and other premises located in Bewal Plaza and Laraib plaza were sealed :

1) Raja Motors 2) London Estate, 3) Rana Trading 4) Japan Motors and Driving School 5) Rahbar Property Centre 6) Saif Motors 7) Waqas Motors 8) Alharam Stamp Papers 9) Khurram Tailors 10) Fashion Tailors.

- Besides, seven (07) cars found parked in the public parking of the Markaz by the showroom owners was also confiscated and locked in Police Station (Karachi Company).

- Moreover, 06 illegally constructed ramps in front of different showrooms were also demolished.

(c) In the wake of operation dated 20.05.2019, most of the cars dealers have shifted their vehicles.

(d) The requisite information is enclosed at **Exhibit- "A"**.

**Minister for Interior (Mr. Ijaz Ahmad Shah):** The Spillways of Simly Dam haven't been opened during the last two months.

The Spillway(s) of Simly Dam are operated when the level of Simly Dam Reservoir exceeds its Maximum Conservation Level (*i.e.* 2315 ft SPD) which hasn't been achieved since September, 2016 due to lesser amount of rainfall in the catchment area.

12. **Mr. Muhammad Aslam Khan:**

*Will the Minister for Interior be pleased to state:*

- (a) *whether it is a fact that thousands of people, having old arms licences, could not get their licences registered with NADRA due to some reason; and*
- (b) *whether the above said body intends to take any steps for revalidation of these thousands of old licences to facilitate the licence holders?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) Yes, people having old licence booklets cannot be processed for computerized arms licences due to ban imposed by Ministry of Interior since 1st Nov, 2018 *vide* MO1 notification No. F.No.811/2013- Arms(NPB) dated 1st August 2018.

- (b) It is beyond the scope of NADRA to decide in this regard.

13. **Ch. Aamir Sultan Cheema:**

*Will the Minister for Interior be pleased to state:*

- (a) *whether it is a fact that CDA has not yet approved the lay out plan of Street Nos.N-3, N-4, N-5, N-6, 123-A, 123-B and 123-C of the National Assembly Secretariat Employees Cooperative Housing Society (Regd), Jinnah Garden, Phase-I, Islamabad; if so, the reasons thereof; and*
- (b) *the time by which the said lay out plan would be approved by CDA?*

**Minister for Interior (Mr. Ijaz Ahmad Shah):** (a) In principle layout plan of NECHS is cancelled/withdrawn by CDA on 16-1-2014. Also the layout plan of Jinnah Garden Housing Scheme sponsored by Federal Employees Cooperative Housing Scheme is withdrawn/cancelled by CDA on 14-9-2018. Street No.3 falls in approved and then cancelled LoP of Jinnah Garden Housing Scheme but street No.N-4, N-5, N-6, 123-B and 123-C does not fall in the approved/cancelled layout plan of Jinnah Garden Housing Scheme. Recently in April 2019, management of Jinnah Garden Housing Scheme submitted combined

layout plan of Jinnah Garden Housing Scheme and National Employees Cooperative Housing Scheme for approval by CDA. Street No. N-4, N-5, N-6, 123-B and 123-C falls in the submitted revised LOP of Jinnah Garden Housing Scheme which is under examination in CDA.

(b) As soon as management of society will submit complete land/planning documents *i.e.* Fard, Aks Shajra, NEC for scrutiny and approval of CDA, the layout plan and NOC of the Society would be processed for approval.

14. **Pir Syed Fazal Ali Shah Jillani:**

*Will the Minister for Interior be pleased to state the present position of the Sawan Garden Phase-II, Islamabad?*
